

KNOW ALL MEN BY THESE PRESENTS,

That in consideration of Eight Hundred and no/100----- DOLLARS

to the undersigned grantor Lewis M. Horton and wife, Carridell Horton  
in hand paid by William E. Horton and Louise Horton  
the receipt whereof is acknowledged we the said Lewis M. Horton and wife, Carridell Horton  
do grant, bargain, sell and convey unto the said William E. Horton and Louise Horton

Shelby County, Alabama, to-wit:

The north 16 acres of uniform width off the  $SE\frac{1}{4}$  of  $NW\frac{1}{4}$  of Section 4, Township 22,  
Range 1 East.

TO HAVE AND TO HOLD Unto the said William E. Horton and Louise Horton

as joint tenants, with right of survivorship, their heirs and assigns, forever; it being the intention of the parties to this conveyance, that (unless the joint tenancy hereby created is severed or terminated during the joint lives of the grantees herein), in the event one grantee herein survives the other, the entire interest in fee simple shall pass to the surviving grantee, and if one grantee does not survive the other, then the heirs and assigns of the grantees herein shall take as tenants in common.

And we do, for ourselves and for our heirs, executors and administrators, covenant with the said grantees, their heirs and assigns, that we are lawfully seized in fee simple of said premises; that they are free from all encumbrances.

that we have a good right to sell and convey the same as aforesaid; that we will, and our heirs, executors and administrators shall warrant and defend the same to the said grantees, their heirs, and assigns forever against the lawful claims of all persons.
