to U.S. in hand paid by Alabama Power Company, a corporation, the receipt whereof is hereby acknowledged, do hereby grant to said Alabama Power Company, its successors and assigns, the right to cut and trim and to keep cut and trimmed, and, remove any trees which now or may hereafter endanger the electric transmission lines and telephone lines of said Alabama Power Company, its successors and assigns, now constructed, or which may hereafter be constructed, on or adjacent to S.W. land or the land in which

we have an interest in Shelby County, Alabama, as hereinafter described:

Permission given to trim trees and install guy wires on pole at rear of house - South guy to be against concrete block

Laundry house and not to block driveway on following described lot; commenced at SE corner of NW $\frac{1}{4}$ of NE $\frac{1}{4}$ of sec. 18, Tp. 21s, R. 2 W and run west 242.7 ft. to east line of Hwy No. 31; thence run N $38^{\circ}15'$ W 430 ft. to point of beginning; continue along same course 158 ft; thence run N 72° E 610 ft; thence run South $29^{\circ}15'$ East 173 ft; thence run N $87^{\circ}15'$ W 282 ft; thence run south $53^{\circ}15'$ west 257.5 ft. to point of beginning, being situated in the NW $\frac{1}{4}$ of NE $\frac{1}{4}$ of Sec. 18, Tp. 21 south, Range 2 west.

Also, the right to install and maintain anchors and guy wires on said land.

In the event it becomes necessary or desirable for Alabama Power Company to move its lines of poles, towers and appliances in connection with the construction or improvement of any public road or highway in proximity to its said power lines, the said Company is hereby granted the right to relocate its said lines of poles, towers and appliances on lands of grantors hereinabove described, provided, however, the said Company shall relocate its said line of poles or towers at a distance not greater than ten feet outside the boundary of the right of way of any such public road or highway as established or re-established from time to time.

TO HAVE AND TO HOLD the same to the said Company, its successors and assigns forever.
