That she is the daughter of Daniel B. Lacey, and knows that her uncle, James W. Lacey died intestate on December 29, 1909 and that her Aunt, Martha Lacey, died intestate on October 19, 1923 and further knows that neither of said persons were married and left as their next of kin and sole surviving heirs at law, Kate Lacey, Emma Lacey, Daniel B. Lacey and Cora Lacey. Further deposing, affiant says that Anne Lacey, the mother of Kate, Emma, Daniel, James, Cora and Martha Lacey, predeceased such persons and left her above named children as her next of kin and sole surviving heirs at law.

Further deposing, affiant says that Lelia M. Lacey was the sister-inlaw of affiant and purchased certain land from the owners of the same by statutory warranty deed on April 3, 1933, and by agreement allowed Kate Lacey. and Emma Lacey to live there during their lifetime. Further deposing, affiant says that the said Kate Lacey died March 20, 1934 and Emma Lacey died March 19, 1945.

Further deposing, affiant says that on July 23, 1956, Lelia M. Lacey and husband, C. D. Lacey executed a warranty deed to Phillip Edward Lacey and Andrew Jackson Lacey which is recordedin the Probate Office of Shelby County, Alabama, in Deed Book 181, page 524 which describes land as follows:

The $E_{\frac{1}{2}}$ of the $SE_{\frac{1}{2}}$ of Section 8, Township 21, Range 3 West, except the South 25 acres thereofand also except 10 acres in the form of a square lying in the NE corner of the above described 80 acres, minerals and mining rights excepted. Also all that part of the $W_{\frac{1}{2}}$ of $SW_{\frac{1}{4}}$ of Section 9, Townsnip 21, Range 3 West lying West of the Montevallo-Elyton Public Road, except the South 312 yards thereo fand except the North 10 chains and 46 links thereof, being bounded onthe North by the property of D. B. Lacey and on the South by property heretofore conveyed to Cora Harris and being a part of the same property conveyed to Grantor by deed recorded in Deed Book 95, page 343 in the Probate Office of Shelby County, Alabama.

Furtherdeposing, affiant says that the said Lelia M. Lacey died intestate in about the year 1956 leaving surviving her, no children or descendants of deceased children and her husband, C. D. Lacey.

Further deposing affiant says that she has never heard the title of Phillip Edward Lacey and Andrew Jackson Lacey questioned in any way.
