THE POINT OF BEGINNING ON THE EAST R-O-W LINE OF CHURCH STREET;
THENCE EAST 50 FT; THENCE NORTH 200 FT; THENCE WEST 50 FT,
MORE OR LESS TO EAST R-O-W LINE OF SAID STREET; THENCE SOUTH
ALONG SAID R-O-W LINE TO POINT OF BEGINNING
