A parcel of land being a part of the West half ($W\frac{1}{2}$) of North-East quarter ($NE\frac{1}{4}$) of
North-west quarter ($NW\frac{1}{4}$), Section 30, Township 19 Range one East lying North of
Highway #280 (formerly known as Highway #91) and more fully described as follows:

Beginning at a point on the North line of the above mentioned Highway
Right-of-way and West line of right-of-way of the Chelsea Game Reserve Lake Road
and running in a northerly direction parallel with west line of the said Chelsea
Game Reserve Lake Road a distance of 315. feet; thence in a westerly direction
280 feet; thence in a southerly direction 315 feet to North line of Highway #280
right-of-way; thence in an easterly direction parallel with north line of highway
right-of-way 280 feet to point of beginning.

heirs and assigns forever.


And We do, for ourselves and for our heirs, executors and administrators,
