SMALL BUSINESS ADMINISTRATION, having received payment in full of said Notes, acknowledges full satisfaction thereof, and hereby directs the Clerk of the Probate Court of Bibb County, Alabama; the Clerk of the Probate Court of Dallas County, Alabama; the Clerk of the Probate Court of Chilton County, Alabama; the Clerk of the Probate Court of Perry County, Alabama; the Clerk of the Probate Court of Shelby County, Alabama; the Clerk of the Probate Court of Hale County, Alabama; and the Clerk of the Probate Court of Autauga County, Alabama, to cancel the foregoing Mortgage Instruments of record, and SMALL BUSINESS ADMINISTRATION does hereby release, relinquish and quitclaim all of its right, title and interest in and to the collateral therein described.
