in hand paid by Arthur Earl Hayes and wife, Christine Hayes


the receipt whereof is acknowledged we the said Willie Cost and Grace Cost

that we have a good right to sell and convey the same as aforesaid; that we will, and our heirs, executors and administrators shall warrant and defend the same to the said grantees, their heirs, and assigns forever against the lawful claims of all persons.
