the following described real estate situated in Shelby County, Ala., to-wit:

From the Northeast corner of the NW<sup>1</sup>/<sub>4</sub> of the NW<sup>1</sup>/<sub>4</sub> of Section 28, Township 19 South, Range 2 West run West along the North boundary line of the said NW<sup>1</sup>/<sub>4</sub> of the NW<sup>1</sup>/<sub>4</sub> of Sec. 28, T. 19S., R. 2W. for 483.67 feet; Thence turn an angle of 92 Degrees, 17 $\frac{1}{2}$  Minutes to the left and run Southerly for 1828.19 feet to the point of beginning of the land herein described; Thence continue Southerly along the same line for 372.47 feet; Thence turn an angle of 34 Degrees, 18 $\frac{1}{2}$  Minutes to the left and run Southeasterly for 386.98 feet; Thence turn an angle of 10 Degrees, 15 $\frac{1}{2}$  Minutes to the right and run Southeasterly for 623.14 feet, more or less, to a point on the North Right of Way line of the Cahaba Valley Road; Thence turn an angle of 97 Degrees, 55 Minutes to the left and run Northeasterly along the North R.O.W. line of the Cahaba Valley Road for 210.0 feet; Thence turn an angle of 82 Degrees, 05 Minutes to the left and run Northwesterly for 623.14 feet; Thence turn an angle of 10 Degrees, 15 $\frac{1}{2}$  Minutes to the left and run Northwesterly for 703.08 feet, more or less, to the point of beginning.

This land being a part of the West  $\frac{1}{4}$  of Section 28, Township 19 South, Range 2 West and being 5.6 acres, more or less.
