I can remember when John Glass and his wife were in possession of both Lots 10 and 11 in Block 10 as tenants of Mrs. F. Stein. John Glass purchased Lots 10 and 11 in Block 10 about the year 1920 from Mrs. F. Stein.

John Glass sold the property to R. L. Holcombe, and during the time that R. L. Holcombe owned the lots, R. L. Holcombe tore down the old house situated on the lots, and built a house on Lot 10 of Block 10.

R. L. Holcombe sold the property to W. H. Crawford, and W. H. Crawford rented the house to various people during the time that he owned the property. W. H. Crawford sold the property to N. D. Thomas, and Thomas lived on the property until he sold the lots to Walter Jackson Glass.

About the year 1953, Walter Jackson Glass sold Lot 11, Block 10, to his nephew, Charles Glass, Jr. and his wife, Burnece L. Glass, and Charles and his wife built a house on Lot 11, and moved into said house, and have been living on said property since that time.

For the past 40 years, I have never known of W. H. Martin, M. E. Johnson or Blanche Sorrell claiming any interest in or title to Lot 11 in Block 10, according to J. H. Dunstan's Survey of Calera, Alabama.

I know of my own personal knowledge that since the purchase by John Glass from Mrs. F. Stein, by deed recorded in Deed Book 67 at page 114, dated February 25, 1920, and his successors in title, that the possession
