Before me, Martha B. Joiner, the undersigned authority in and for said County in said State, personally appeared Jimmy Humphries, who, after being by me first duly sworn to speak the truth, deposes and says:

My name is Jimmy Humphries. I am 43 years of age and have lived in Shelby County, Alabama, for the past 12 years. About the year 1954 or 1955, I built a cabin on land belonging to C. B. Kirkpatrick and which was near the hereinafter described land and I am familiar with the following described land which I understand is owned by Lewis B. Walker; viz:

Part of NW $\frac{1}{4}$ of SE $\frac{1}{4}$ of Section 13, Township 22 South, Range 1 East, more particularly described as follows: Commencing at the northwest corner of said NW $\frac{1}{4}$ of SE $\frac{1}{4}$ of said Section 13 and run east along the north line of said forty acres to a point where the 425 foot contour line of Alabama Power Company crosses the north line of said forty; thence in a southwesterly direction along said contour line to a point where said 425 foot contour line crosses the west line of said NW $\frac{1}{4}$ of SE $\frac{1}{4}$ of said Section 13; thence north along the west line of said forty acres to point of beginning, containing 20 acres, more or less, and being situated in Shelby County, Alabama.

Affiant further says he knows where the south line of the Kirkpatrick land is located and the south line of said Kirkpatrick land ran along a little cross-tie bridge over a branch that goes down to a slough. Affiant further says the above described land did not belong to C. B. Kirkpatrick and that Mr. Kirkpatrick pointed out the south line of his property to affiant and it lay northeast and up the river from the above described property.
