KNOW ALL MEN BY THESE PRESENTS, that, as a donation, the UNITED STATES STEEL CORPORATION, a New Jersey corporation, hereinafter sometimes referred to as "Grantor," to the extent of its ownership, hereby grants and conveys', upon the terms, conditions; and limitations hereinafter set forth, to SHELBY COUNTY, ALABAMA, hereinafter sometimes referred to as "Grantee," an easement for a right of way for a public road over certain land in the South-West quarter of North-East quarter and North-West quarter of South-East quarter of Section 31, Township 21 South, Range 4 West, of the Huntsville Principal Meridian, Shelby County, Alabama, located as shown on map attached hereto and made a part hereof.
