

Commence at the NE corner of the SEZ of NWZ of Section 11. Township 21 South, Range 3 West, Shelby County, Alabama; run thence South 89 deg. 15 min. West a distance of 437 feet to a point on the West right of way line of the Siluria-Montevallo Highway; thence run along the West right of way line of said road South 10 deg. 28 min. Fast a distance of 162.00 feet to the point of beginning of the land herein described and here con-veyed; thence run South 84 deg. 32 min. West a distance of 136.80 feet; thence run South O deg. 47 min. West a distance of 39.20 feet; thence run South 89 deg. 15 min. West a distance of 1356.54 feet; thence run South 2 deg. 17 min. West a distance of 442.12 feet to the center of a mock orange hedge row; thence run North 86 deg. 15 min.
