SUBORDINATION

(Alabama and Mississippi Federal Land Bank Loans)

For value received, The Federal Land Bank of New Orleans, being the present owner of the indebtedness secured by that certain mortgage or deed of trust executed by William W. Barnett & Virginia R. Barnett, recorded in Book 261, Page 71, of the land mortgage records of Shelby County, Alabama, does hereby subordinate said mortgage (deed of trust) to that certain Right of Way granted by William Barnett and Virginia Barnett to Shelby County Highway Department on May 8, 1961, as to the following described land:

Beginning at a point on the center line of Project SACP 4245-B at Station 71+38, the west property line; thence south along said property line a distance of approximately 24 feet to the south property line; thence along said south property line in an easterly direction approximately 1720 feet to intersect the north 40 foot right of way line of said project 40 feet left of Station 88-50, thence N 88 degrees 37' along said right of way line a distance 854.1'; thence north easterly along a 0 deg. 40' curve to the left a distance 538.4'; thence south 87 deg. 48' W a distance of 319.5' to a point on the west property line; thence south along the property line a distance of 40' to the point of beginning. Said strip of land is lyint in the SE $\frac{1}{4}$  of NW $\frac{1}{4}$  of NE $\frac{1}{4}$ , Sec. 34, T 21S, Range 1 East and contains 1.24 acres, more or less, including that part now occupied by the present road. An easement is also granted for a channel change left of the culvert to be built at Station 72-89 to Station 73-40 of said project and at right angle in a northerly direction for approximately 125 feet north of the North 40 foot right of way line.
