## RIGHT-OF-WAY RELEASE FOR MORTGAGEE

and other good and valuable considerations do hereby release the following described property for
right-of-way for a state road from the operation of that certain mortgage made by JS Massey
R. C. Collins as recorded in the office of the Judge of Probate of
Which right-of-way shall befeet in width onside of the center line of said road,
as it is now located and staked out by the State Highway Department or as much of the said property
as is required to make a foot right-of-way which is more particularly described as follows,
to wit:
Beginning at a point on the centerline of Project SACP 4391-A at Station 224+26, the west property line; thence northeasterly along the center-line along a 6° curve to the left a distance of 619.1'; thence along the center-line N 7° 41' E a distance of 230' to the point of ending at Station 232+76, the north property line.
Said strip of land being 40' wide on the right (southeast) side of centerline of said project also to include a flare on the right beginning at a point 40' right of Station 232+10, thence along the 40' right of way line N 7° 41' E a distance of 68'; thence went along the south L & N Railroad right of way line a distance of 75'; thence southwesterly a distance of 100' to the point of beginning. Said land is lying in the SE4 of SE4, Sec. 12, T21 S, R 3 W and contains 0.91 acre, more or less, including that part now occupied by the present road.
The above described property shall be used solely as a right of way for a State Highway. This release shall not in anywise affect the validity of the mortgage herein above mentioned which shall remain in full force and affect, insofar as the other property therein described is concerned.
