My name is Clint Jackson, and I am 62 years of age, and have lived in Siluria and Alabaster, Shelby County, Alabama, for the past 35 years or more. I am presently residing in the house situated on the property owned by me which is located about three-fourths mile from the herein-after described property. I have been employed at Longview Lime Company, Saginaw, Alabama, for the past 13 years.

I have been acquainted with the possession and ownership of the following described property for approximately 35 years:

A part of the SW $\frac{1}{4}$ of NW $\frac{1}{4}$ of Section 1, Township 21 South, Range 3 West more particularly described as follows: From the SE corner of the SW $\frac{1}{4}$ of NW $\frac{1}{4}$ of Section 1, run West along the South boundary line of said Quarter-Quarter Section for 664.96 feet; thence turn an angle of 88 deg. 30 $\frac{1}{2}$ min. to right and run Northerly 208.75 feet; thence turn an angle of 71 deg. 32 min. to right and run Northeasterly 168.10 feet to the point of beginning of the land herein described and conveyed; thence turn an angle of 97 deg. 30 min. to the left and run Northwesterly for 104.35 feet; thence turn an angle of 97 deg. 30 min. to right and run Northeasterly for 104.35 feet; thence turn an angle of 82 deg. 30 in. to the right and run Southeasterly for 104.35 feet; thence turn an angle of 97 deg. 30 min. to the right and run Southwesterly for 104.35 feet to point of beginning. Situated in Shelby County, Alabama.

When I first became acquainted with the possession and ownership of the property, it was claimed and possessed by Reuben Walker and his wife Mattie Walker. I remember the year 1945, when Reuben Walker and his wife Mattie Walker sold an acre of property to Mattie Stewart and son, Roosevelt Wright, as described in deed recorded in Deed Book 120 at page 410 in the Office of Judge of Probate, Shelby County, Alabama. After Mattie Stewart and son Roosevelt Wright bought the acre of property, they went into possession of same, and used the property for pasture up until the time that the property was recently sold to Charles Swain and his wife M. Gertrude/Swain.

I know of my own personal knowledge that the property described above is a part of that property described in the deed recorded in Deed Book 120

at page 410, in the Office of Judge of Probate, Shelby County, Alabama.

I know of my own personal knowledge that the possession of Reuben Walker and his wife Mattie Walker, and Hattie Stewart and her son Roosevelt Wright, of the above described property has been continuous, exclusive, peaceful, quiet, notorious, direct, adverse and hostile and under color of title and claim of ownership since the year 1936, up until the 23rd day of March, 1961, on which date Hattie Stewart and her husband Johnnie Stewart executed a deed to Charles Swain and wife Gertrude Swain, conveying the above described property.

I further know of my own personal knowledge that for more than the past 20 years no one has been in possession of any part of said property claiming adverse to said owners, nor have I ever known of anyone claiming any right, title, or interest in or to said property, adverse to said owners, nor have I ever heard anyone dispute or question the title of said owners to said property.
