That in consideration of Eight hundred and No/100(\$800.00)-----DOLLARS

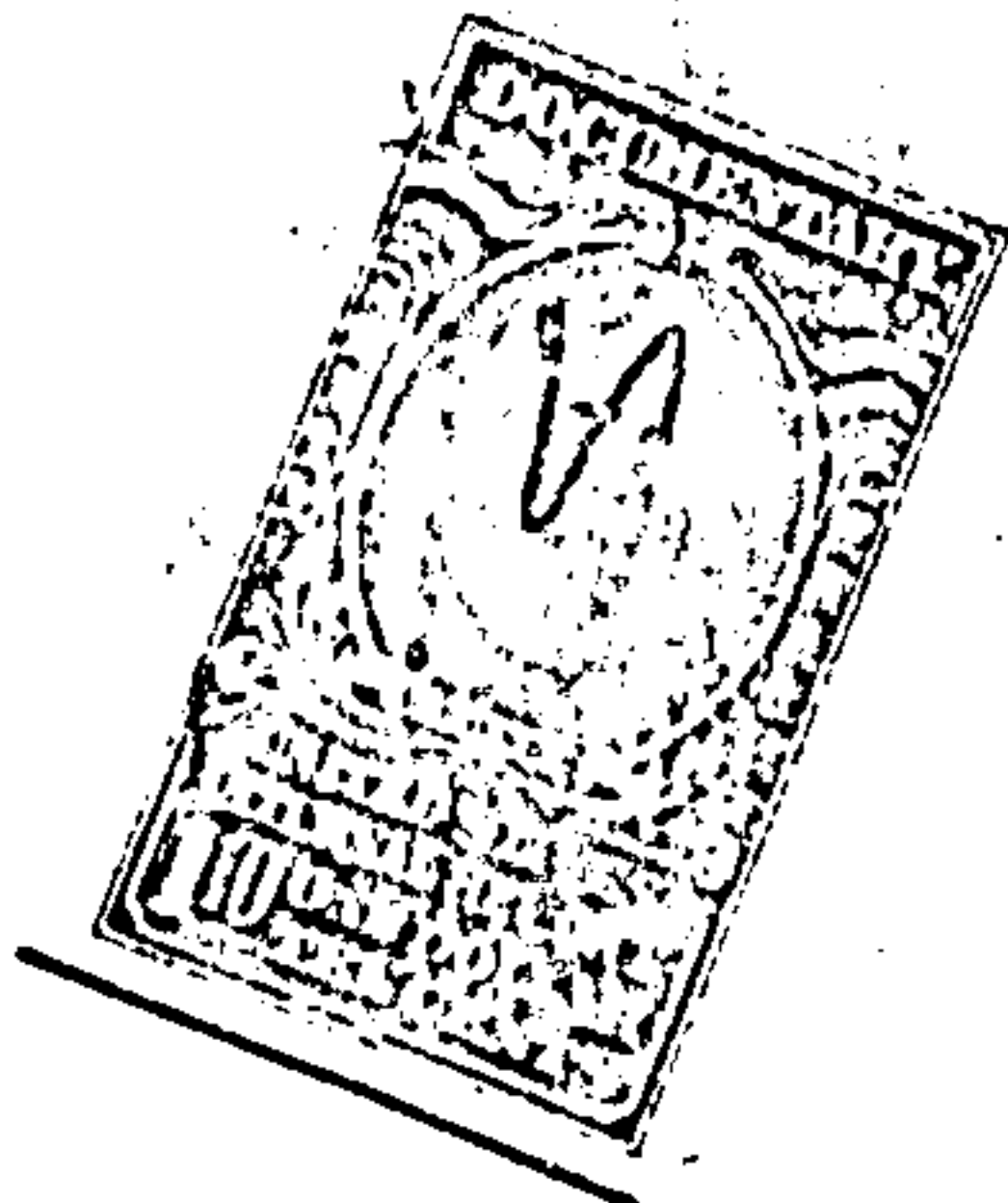
to the undersigned grantor W. C. Bowdoin and wife, Opal Bowdoin
