Before me, a Notary Public, in and for said County, in said State, this day personally appeared John M. Green, known to me, and who after being first duly sworn deposes and says as follows:

I am a grandson of Sarah E. Green who died in about the year 1904. My grandmother, during her lifetime, had been the owner of certain real estate, situated in Bibb County, Alabama, included in which was the following described real estate:

The East 330 feet of the NW% of SE% or Section 22, Township 21 South, Range 6 West.

I was born in the year 1887 and I have lived in the neighborhood of this property practically all of my life and am living in the neighborhood of this property at this time. I am acquainted with the names of the heirs of my grandmother, Sarah E. Green, and, of course, have known all of them. I have been shown an abstract of title on this real estate described above and in this abstract there appears a deed dated June 23, 1949, of record in Volume 52 of Deeds, at page 63, in the Office of the Judge of Probate of Bibb County, Alabama, it being the deed which was signed by me and my wife and others. This deed conveyed the property described above to H. T. Stapp. I have also been shown a deed in this abstract dated August 30, 1950, of record in said Probate Office in Volume 53 of Deeds, at page 333. This was a deed from H. T. Stapp and wife to A. K. Hamilton and others. This deed also covered the real estate described above. This last deed contained a statement that the grantees were all of the heirs of Alice J. Hamilton. These grantees did in fact constitute all of the heirs at law of Alice J. Hamilton who died many years ago. Alice J. Hamilton was a daughter of my

grandmother, Sarah E. Green. My grandmother, Sarah E. Green, had five children, they having been Alice J. Hamilton, Mary C. Caffee, John Green, James W. Green and George Green. The said John Green, who was my uncle, died many years ago. The said John Green had one son who died in the year 1933 leaving no children as his heirs at law and his wife is dead. The said George Green, also one of my uncles, died many years ago and left no children or wife surviving him. The heirs of the said Alice J. Hamilton were the grantees in this deed from H. T. Stapp referred to above. The heirs of Mary C. Caffee were the grantees in this deed to H. T. Stapp which was signed by me and others.

My father, James W. Green, died many years ago and his children were Charles Green, Randall Green, John M. Green, your affiant, and Robert Green. My brothers, Randall Green, Robert Green, and I all signed this deed to H. T. Stapp. My brother, Charles Green, was dead in 1949, and his children were Noah Green, Annie Wyatt, Glenn Kellum, Murray Green and Gladys Bryant. All of these heirs of my father signed this deed to H. T. Stapp.

The various persons who were parties to these two deeds which I have referred to constituted all of the heirs at law of Sarah E. Green and all of the heirs of Sarah E. Green have now conveyed their interest in this real estate.
