ASSIGNMENT OF MORTGAGE

Cowart, do hereby transfer and assign, bargain, sell and convey unto the said Z. S. Cowart the note described in the mortgage and all my right, title and interest in said mortgage and in and to the property therein described, which said mortgage and property are as follows:

That certain mortgage executed by Gus McMikel, Arthur Lee, Ollie Williams and Joe Kelley, as Trustees of the Macedonia Baptist Church to Glynn N. C. Jones, Sr. dated July 14, 1961, for the principal sum of \$6,650.00 plus 8 per cent interest per annum from date, recorded in Mortgage Book 273 page 124 in the Probate Office of Shelby County, Alabama, which said mortgage covers the following described land:

Commence at the northeast corner of the NW $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Section 26, Township 21 South, Range 1 West, thence run west along the north line of said Section 26 a distance of 635.8 feet; thence turn an angle of 37 deg. 54 min. to the left and run a distance of 150.80 feet to the center of Shelby Iron Company's Railroad (now abandoned); thence turn an angle of 27 deg. 50 min. to the left and run a distance of 42.45 feet to the south right of way of said railroad and the point of beginning; thence continue in the same direction a distance of 212.75 feet to the north right of way of Depot Street; thence turn an angle of 79 deg. to the left and run along the north right of way line of Depot Street, a distance of 139.50 feet; thence turn an angle of 101 deg. 00 min. to the left and run a distance of 82.18 feet; thence turn an angle of 29 deg. 23 min. to the right and run a distance of 103.77 feet to the south right of way of said railroad; thence turn an angle of 99 deg. 49 min. to the left and run a distance of 199.36 feet to the point of beginning; situated in the NW $\frac{1}{4}$ of the NE $\frac{1}{4}$ of said Section 26 in Columbiana, Shelby County, Alabama.
