Chesser's store building, and South of Main Street of Chelsea, Alabama. The said lot is 50 feet wide, East and West, on the South side of said Main Street, and 125 feet long, running North and South of said Main Street, and situated in the NW4 of the NE% of Section 34, Township 19, Range 1 West.

Grantor further conveys to grantee all the rights and privileges necessary or convenient for the full enjoyment or use thereof of said easement, and also the right to cut and keep clear any and all trees, and to keep clear other obstructions that may injure or endanger said septic tank or field lines.
