## AFFIDAVIT

Before me, a Notary Public, in and for said County and State, personally appeared Nathan D. Wyatt, who is known to me, and who being by me first duly sworn, deposes and says as follows:

My name is Nathan D. Wyatt. I am fifty-one years of age, and I have been personally fimiliar with the conership and possession of the following described property as long as I can remember—for more than forty years—having been born within two miles of said property and having lived and resided within three miles of said property all of my life:
