# TRUSTEE'S DEED

# KNOW ALL MEN BY THESE PRESENTS:

This Indenture made this 20 day of October, 1961, between Frank S. Blackford, as Trustee in Bankruptcy of the Estate of Juanita D. WHEREAS, a voluntary petition in bankruptcy was filed by Juanita D. Acton and Curtis Lee Acton, Sr., individually and as Curtis Lee Acton, Sr., formerly doing business as C.L. Acton Home Improvements Company, and said parties were duly adjudicated bankrupts thereon; and,

WHEREAS, subsequent to said adjudication Frank S. Blackford was duly elected Trustee of the above named bankrupt estates, qualified as such Trustee, and has continued to act and is now acting as such Trustee in the said bankrupt estates; and,

WHEREAS, application was made by said Frank S. Acton to Exchange Security Bank which mortgage is recorded in Volume 258, at Page 491 in the Probate Office of Shelby County, Alabama and also the assumption of ad valorem taxes for the year 1961; and notice having been given to all scheduled creditors to show cause why said sale should not be confirmed and no creditor appearing and objecting thereto the Court made and entered an order confirming said sale which order of confirmation is dated the 10th day of October, 1961.
