do grant, bargain, sell and convey unto the said

as joint tenants, with right of survivorship, the following described real estate, situated in

Shelby

County, Alabama, to-wit:

Commence at the northwest corner of NW $\frac{1}{4}$ of NW $\frac{1}{4}$ of Section 16, Township 21, Range 1 West, and run thence east along the north line of said forty acres 120 feet, more or less to the west right of way line of old Columbiana-Elyton paved road; thence run in a southerly direction along the west right of way of said road 348 feet to the point of beginning of the lot herein conveyed; thence continue in the same direction southerly along the west line of said road 185 feet; thence west and perpendicular to said road run 104 feet; thence north and parallel with said road run 167 feet to the north line of the grantors lot; thence east along same 104 feet to the point of beginning.

TO HAVE AND TO HOLD Unto the said John B. Finley and Lallage L. Finley

as joint tenants, with right of survivorship, their heirs and assigns, forever; it being the intention of the parties to this conveyance, that (unless the joint tenancy hereby created is severed or terminated during the joint lives of the grantees herein), in the event one grantee herein survives the other, the entire interest in fee simple shall pass to the surviving grantee, and if one grantee does not survive the other, then the heirs and assigns of the grantees herein shall take as tenants in common.

And we do, for ourselves and for our heirs, executors and administrators, covenant with the said grantees, their heirs and assigns, that we are lawfully seized in fee simple of said premises; that they are free from all encumbrances.

that we have a good right to sell and convey the same as aforesaid; that we will, and our heirs, executors and administrators shall warrant and defend the same to the said grantees, their heirs, and assigns forever against the lawful claims of all persons.
