Vincent, Alabama, for and in consideration of the sum of one and no/100 Dollars (\$1.00), to it in hand paid by Alabama  
Power Company, a corporation, the receipt whereof is acknowledged does hereby grant  
to said Alabama Power Company, its successors and assigns, the right to construct,  
operate and maintain its lines of poles and towers and appliances necessary in con-  
nection therewith, as located by the final location survey heretofore made by said  
Company, ~~which shall be approved by the Trustees of said Church~~ for the transmission of electric power, with the right to string thereon  
from time to time, electric power and telephone wires and the right to permit other  
corporations and persons to attach wires to said poles and towers upon, over and  
across the following described land situated in Shelby County, Alabama;  
"3 1/2 acres, out of the NE 1/4 of the NW 1/4, Sec. 11, Tsp. 19, R. 2 E., and more  
particularly described as follows: Commence and run 260 ft. N. of the S. line of  
said 40 and at a point on the W. R/W line of U. S. Highway 231; thence run along  
the S. boundary of the Hulen Southern lot as shown by deed recorded in the office  
of the Judge of Probate, Shelby County, Alabama in deed record 160 at page 506,  
a distance of 208 feet to the point of beginning; thence continue due W. a dis-  
tance of 364 ft. to a point; thence run NE. and parallel with R/W line of said  
U. S. Highway 231 a distance of 416 ft. to a point; thence run due E. a distance  
of 364 ft. to a point and said point being the NW corner of said Hulen Southern  
lot; thence run SW. along the W. line of said Hulen Southern lot and parallel with  
the W. R/W line of said Highway a distance of 416 ft. to the point of beginning.  
Said parcel of real estate being situated in the NE. 1/4 of the NW. 1/4. Sec. 11,  
Tsp. 19, R. 2 E. in the town of Vincent, Alabama"

Together with all the rights and privileges necessary or convenient for the  
full enjoyment or use thereof including the right of ingress and egress to and from  
said lines; and also the right to cut and keep clear all trees, and to keep clear  
other obstructions, that may injure or endanger said lines.

forever.
