IN THE SHELBY COUNTY LAW AND EQUITY COURT

This cause coming on to be heard upon the verified petition of Pauline Baker as mother of Mary Baker for the removal of the disabilities of non-age of the said Mary Baker, this being the day set by a former order of this Court to hear and determine said petition:

Now comes the petitioner, and the testimony of the witnesses having been taken by affidavit pursuant to the direction of the Court as noted by the Register, and the Court finding that the facts stated in the said petition are true; that the said Pauline Baker resides in Harpersville, Shelby County, Alabama; that the said Mary Baker resides with petitioner and is presently employed as a bookkeeper in Birmingham, Alabama; that the father of the said Mary Baker is dead and that she, the said Mary Baker, is over the age of 18 years and will reach her twenty-first birthday on, to-wit, January 25, 1963; and the Court being satisfied that it will be to the best interest of said minor to be relieved from the disabilities of non-age, and no objection being filed to the granting of said petition, it is, therefore,

CONSIDERED, ORDERED, ADJUDGED and DECREED that the prayer of said petition be and hereby is granted; that it will be to the interest of the said minor, Mary Baker, to be relieved from the disabilities of non-age unconditionally and without restriction.

It is further CONSIDERED, ORDERED, ADJUDGED and DECREED That the said Mary Baker be and hereby is relieved from the disabilities of non-age unconditionally and without restriction and that she be and hereby is invested with the right to sue and be sued, contract, buy, sell and convey real estate and generally to do and perform all acts which she could lawfully do if twenty-one years of age; that a duly certified copy of this decree be filed for record in the office of the Judge of Probate of Shelby County, Alabama; that the petitioner pay the costs in this behalf incurred.

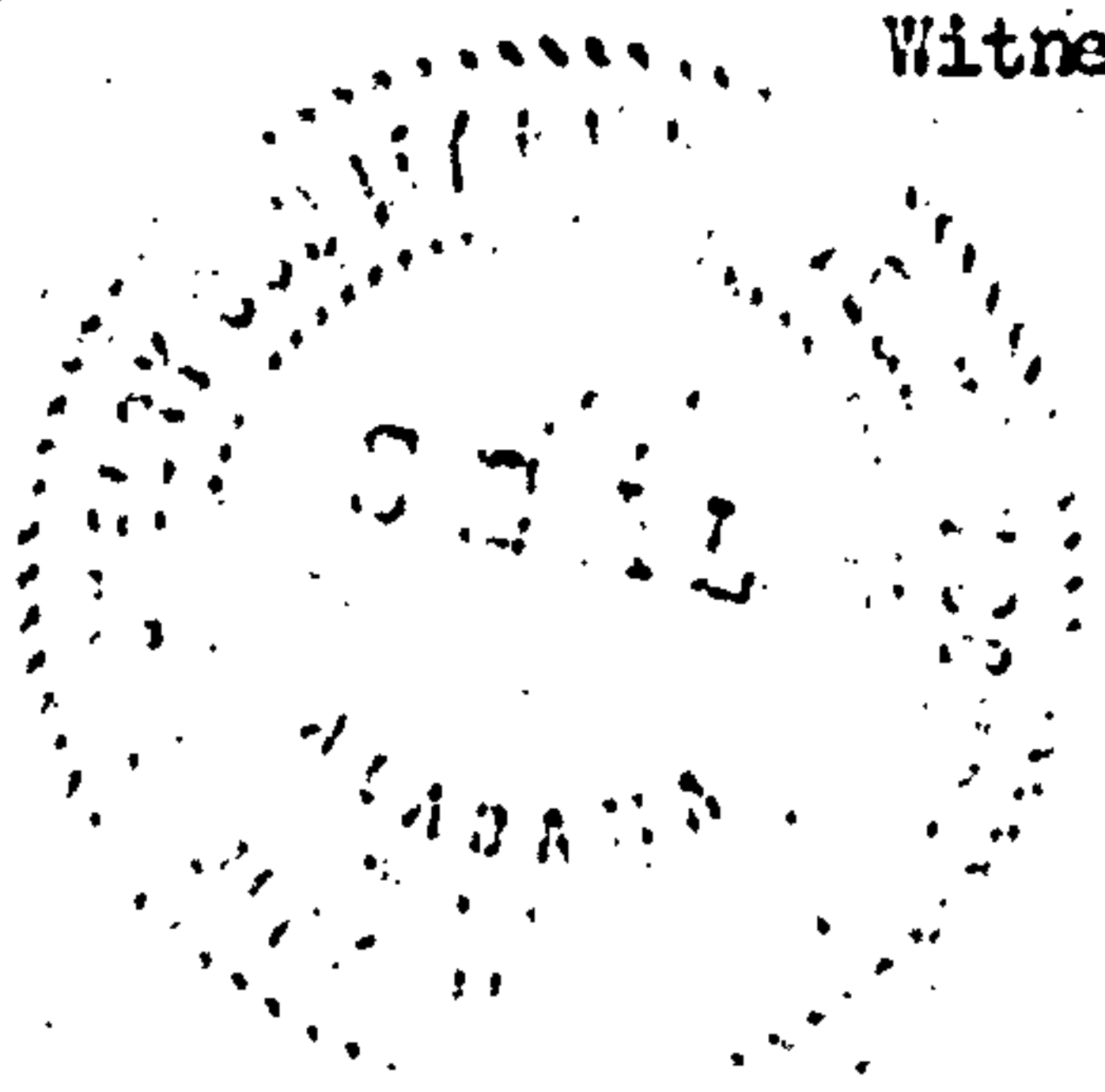
