O deg. 24 min. to the right of preceeding course a distance of 159.68 feet to a point on said curved right of way line marked by a truck axle and the point of beginning of said tract; thence along a segment of this curve, subtended by a chord having a length of 209.9 feet and making an angle of 3 deg. 25 min. to the right of previous chord, a distance of 210.0 feet; thence at an angle to the right of 49 deg. 36 min. a distance of 420.0 feet; thence at an angle to the right of 130 deg. 24 min. a distance of 209.9 feet; thence at an angle to the right 49 deg. 36 min a distance of 420.0 feet to point of beginning.
