in connection with and as part of the aforesaid grantees' communication lines and systems.

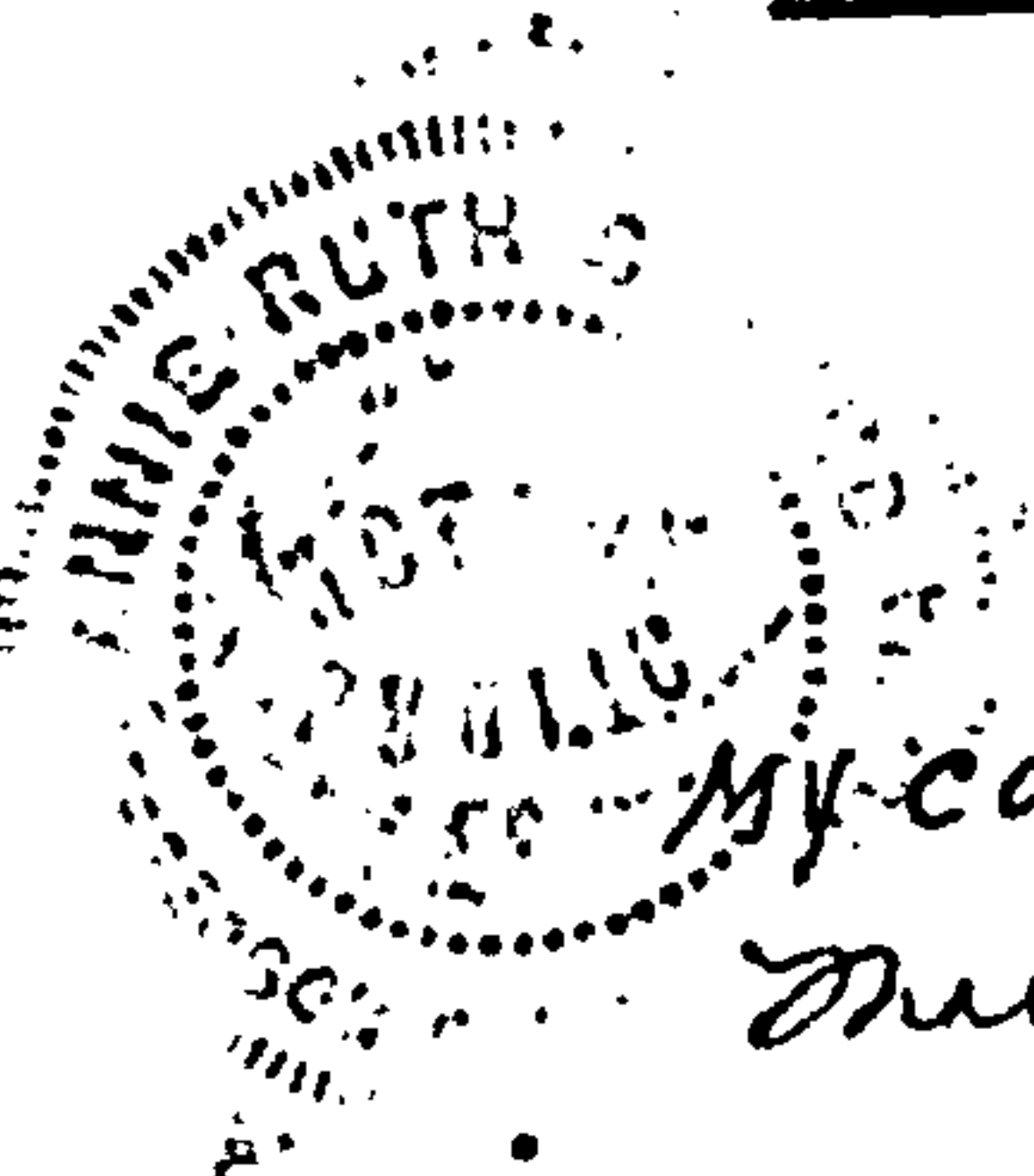

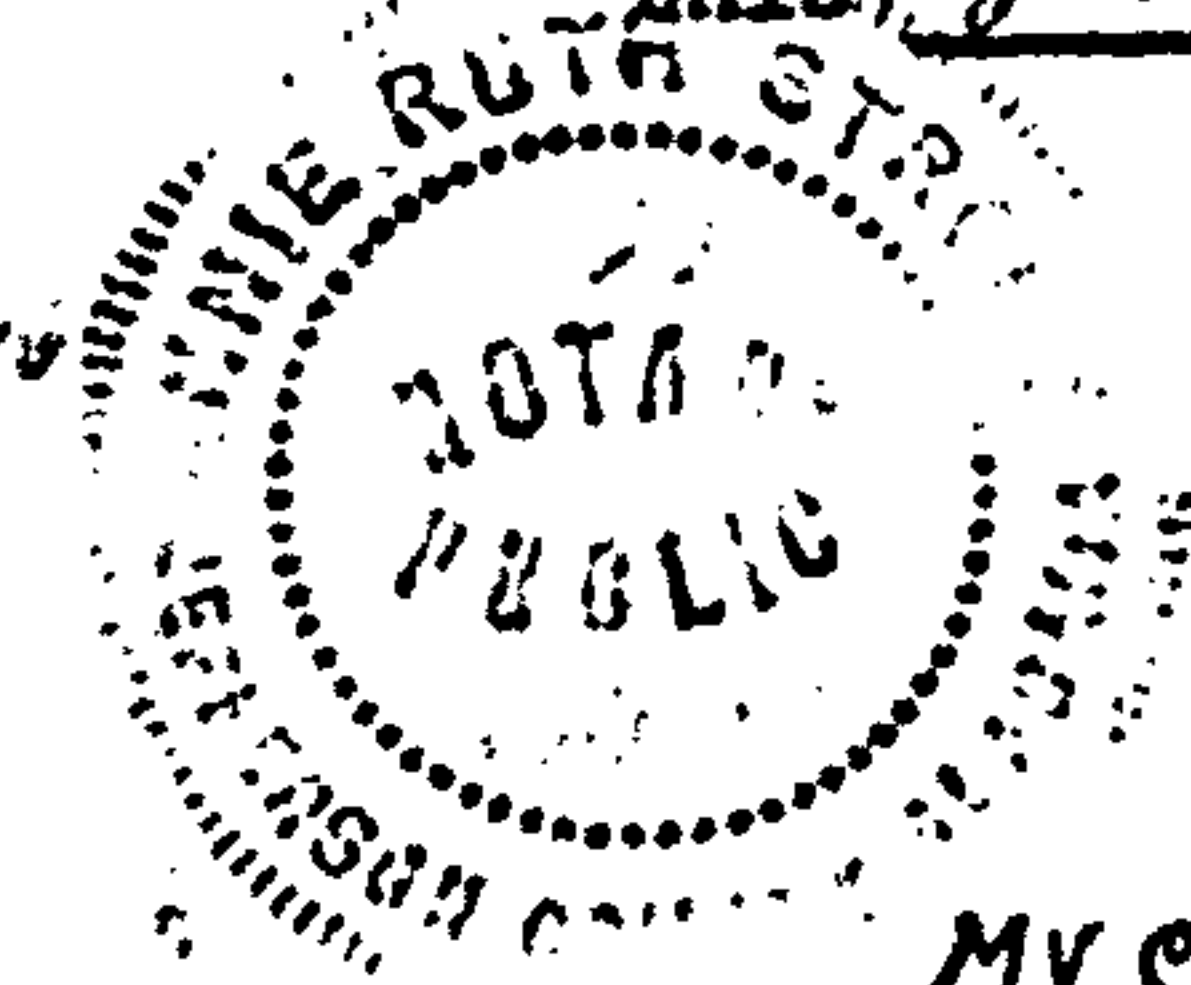
