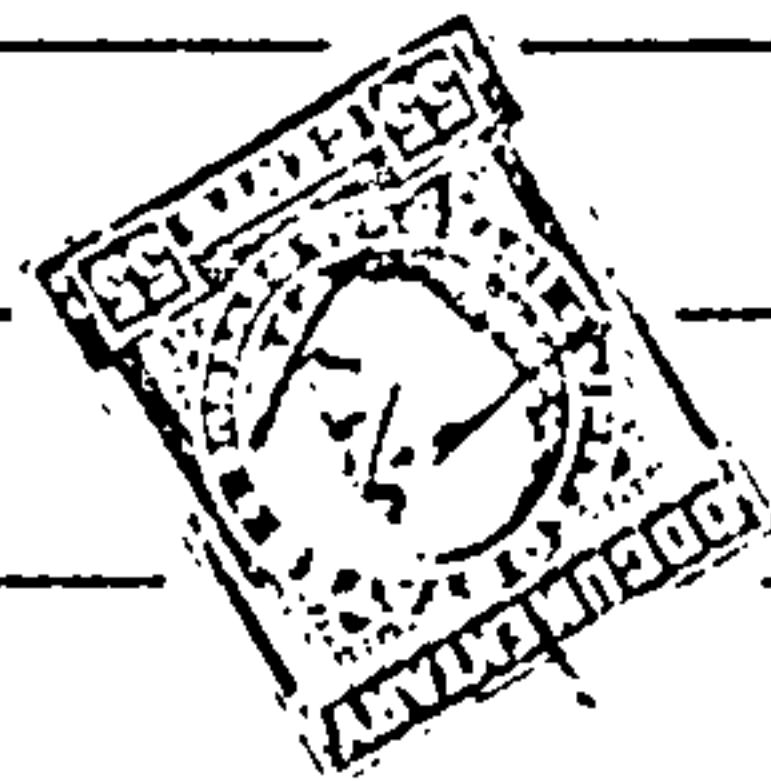

the following described real estate, to-wit: A part of the NW $\frac{1}{4}$ of NW $\frac{1}{4}$ of Section 22, Township 21 South, Range 3 West, More particularly described as follows: Commence at the NE corner of NW $\frac{1}{4}$ of NW $\frac{1}{4}$ of said Section 22, Township 21, range 3 West and run thence Westerly along the North boundary of said Quarter Quarter Section 437.32 feet to a point of beginning of the land herein conveyed; thence turn an angle of 90 deg. to the left and run thence 208.71 feet in a Southerly direction, and parallel with the East boundary of said Quarter Quarter Section, to a point; thence turn an angle of 90 deg. to the right and run thence Westerly 208.71 feet to the East boundary of a proposed street; thence turn an angle of 90 deg. to the right and run thence Northerly along the East boundary of said street and parallel with the East boundary of said Quarter Quarter Section 208.71 feet to a point; thence turn an angle of 90 deg. to the right and run thence Easterly, along the North boundary of said Quarter Quarter Section, 208.71 feet to the point of beginning, containing one acre more or less.

Said above described land shall be used for residential purposes only and no commercial building or business shall be carried on on said land and it is agreed and understood that this shall be a covenant running with the land and shall bind the grantees, their heirs and assigns, and should there be a breach thereof, the same may be enjoined in any court of competent jurisdiction.
