At a regular business meeting of the Board of Stewards of Union Methodist Church duly assembled in said Church in Shelby County, Alabama, on Saturday, May 26, 1962, at 7 P.M., at which time a quorum of said Board was present and voting, the following resolution was presented:

"Resolved that the Union Methodist Church, Shelby County, Alabama, grant and execute a right of way easement for a 36" Pipe Line in favor of the COLONIAL PIPELINE COMPANY on and across the South Half of the Southwest Quarter of the Northeast Quarter (St of SWt of NEt) of Section 32. Township 19 South, Range 1 East, in Shelby County, Alabama; said pipe line to cross said tract of land a distance of 69 rods and is to be 75 feet in width during the period of construction, and after construction and clean-up, then the said permanent right of way shall be 50 feet in width, extending 35 feet on the south side and 15 feet on the north side of the center line of said pipe line then in place. Be it further resolved that Wade Maske, Chairman of the Board of Stewards of said Union Methodist Church, be and he is hereby authorized to execute said right of way easement for and on behalf of said Union Methodist Church and to receipt for the payment of Advance Construction Damages in connection with the construction of said pipe line; the payment to be made to Union Methodist Church being \$69.00 for the right of way and \$345.00 for Advance Damages, making a total payment of \$414.00.

After a full discussion the above resolution was put to a vote and was unanimously passed, there being no dissenting votes.
