

West 100 feet; thence south 25 deg. West 100 yards; thence south 75 deg. West 200 feet to old Livery stable barn; thence south'70 deg. West 100 feet to Chelsea & Columbiana Road; thence south 10 deg. West along East side of said road 100 yards to a point; thence south 30 deg. West 100 feet; thence South 2½ deg. East 400 feet to point; thence south 45 deg.
