I, the undersigned Henry M. Abercrombie, of Birmingham, Jefferson County, Alabama, being over the age of twenty-one years, and of sound mind and disposing memory, do hereby make, publish and declare this to be my last will and testament, hereby expressly revoking all former wills or codicils heretofore at any time made by me.

ITEM ONE.

I hereby give, devise and bequeath unto my wife, Myrtie M. Abercrombie, all my property of which I may die seized and possessed, or in which I may have any interest or equity, whether real, personal or mixed, and regardless of where the same may be located or situated, to have and to hold, absolute and in fee simple.

ITEM TWO.

Should my wife, Myrtie M. Abercrombie predecease me, then in that event, I do hereby give, devise and bequeath unto my son, Jarrett Abercrombie, and my daughter, Mildred Abercrombie Barr, all my property of which I may die seized and possessed, or in which I may have any interest or equity, whether real, personal or mixed, and regardless of where the same may be located or situated, to share and share alike, and to have and to hold, absolute and in fee simple.

ITEM THREE.

Should my wife predecease me, and should either of my said children predecease me, and leave surviving him or her a child or children, then in that event, I hereby give, devise and bequeath to such surviving child or children the share that would have gone to such deceased parent. However, should either of my said children predecease me and leave surviving him or her no child or children, then in that event, I hereby give, devise and bequeath to my such surviving child all my property which I may own at the time of my death, or in which I may have any interest or equity.

ITEM FOUR.

I hereby nominate and appoint my wife, Myrtie M. Abernombie, to be executrix of this my last will and testament, and I hereby direct that she be relieved of the duty or obligation of making bond, or of accounting to any court as to how she has discharged this trust hereunder.

ITEM FIVE.

Should my wife, Myrtie M. Abernombie, predecease me, then in that event, I hereby nominate and appoint my son, Jarrett Abernombie, and my daughter, Mildred Abernombie Barr, jointly or either of them as may qualify hereunder, to be executors of this my last will and testament, and I hereby direct that they jointly and severally be relieved of the duty or obligation of making bond, or of accounting to any court as to how they or either of them have discharged this trust hereunder.
