LAST WILL AND TESTAMENT

I, Andrea Simonetti, a resident of the City of Birmingham, Jefferson County, Alabama, being of sound mind and disposing memory and over the age of twenty-one years, do hereby make, publish and declare this instrument to be my last will and testament, hereby specifically revoking any and all wills, and codicils thereto, heretofore executed by me.

ITEM ONE

I hereby direct that all of my just debts, including the expenses of my last illness and funeral, be paid by my Executor, hereinafter named, as soon after my death as he shall deem expedient.

ITEM TWO

I hereby give, devise and bequeath all the rest and residue of my property, of whatsoever kind and character and wheresoever situated, unto my beloved wife, Maria Anselmo Simonetti, all to be hers absolutely.

ITEM THREE

I hereby nominate, constitute and appoint my beloved son Joe Andrew Simonetti as the Executor of this my last will and testament, and I hereby specifically exempt him from giving any bond or bonds whatsoever in connection with his appointment as such Executor and in connection with his acts and doings as such Executor, any and all bonds being hereby specifically included and waived. I do hereby further specifically exempt my said Executor from filing any inventory or appraisement of my estate and from making any report whatsoever to any court or person of his acts and doings as the Executor of my estate. And I do hereby further specifically authorize and empower my said Executor to sell all or any part of the assets of my estate, at such times, upon such terms and conditions, and at either public or private sale, as he shall personally deem proper, without securing authority therefor from any person or court whatsoever.

B. In the event Joe Andrew Simonetti and Sam F. Simonetti predecease me, I hereby nominate, constitute and appoint my beloved son John A. Simonetti as Executor of this my last will and testament, and do specifically grant to him the same powers and exemptions as are hereinabove granted to my Executor in Item Three of this will.
