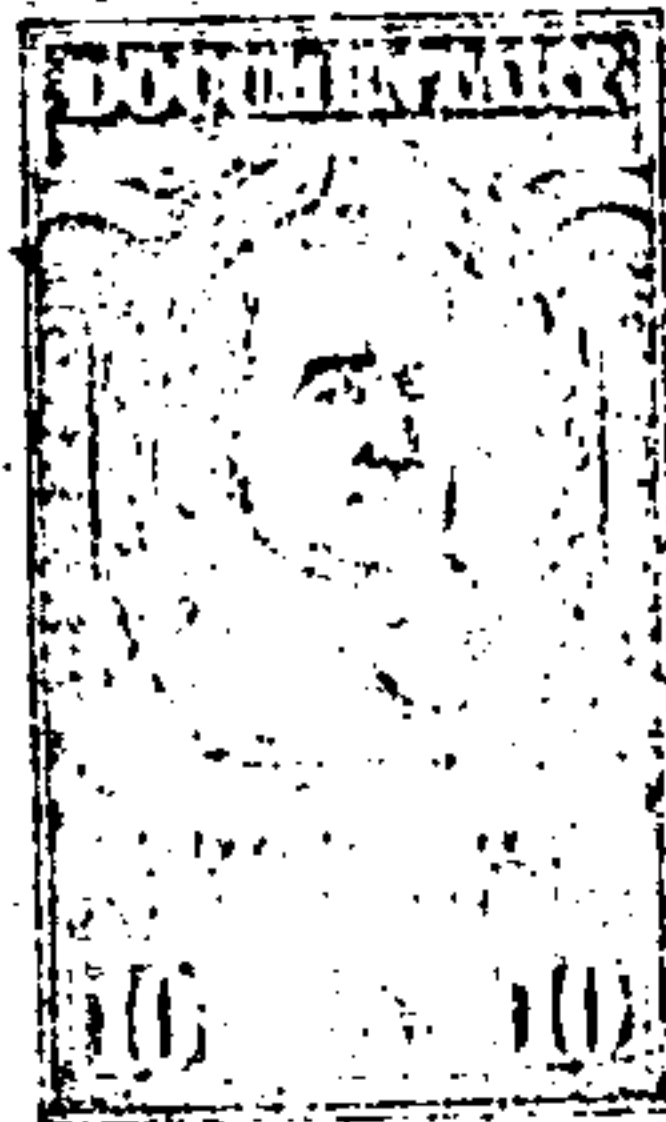

the following described real estate, situated in Shelby County, Alabama, to-wit:

Lots 3 and 4 according to J.P.Word's Addition to the Town of Calera, Alabama, according to the map or plat on file in the Probate Office of Shelby County, Alabama. Said two lots have a frontage of 120 feet along the West side of Word Street with the North boundary being 135 feet, more or less and the South boundary being 161 feet deep, more or less.

Also an easement and right of way granting the right to the full use and enjoyment of the sewage line which runs across or under Lot 13 of the said Word's Addition to the Town of Calera, Alabama, together with the right to enter upon said lot 13 to repair said sewage in the event that such repair ever becomes necessary. Said lot 13 being across the street from the said lots 3 and 4. Said easement is to be a covenant running with the land of lot 13 so long as said sewage is necessary to service said lots 3 and 4.
