

## 4093 CHATTEL MORTGAGE

KNOW ALL MEN BY THESE PRESENTS, That I (we) H. S. and Gladys Wilton

of (Town) Rt #1 Street, (County) Shelby, (State) Ala.,  
 hereinafter called (whether one or more) Mortgagor, for good and valuable consideration, to me (us) paid by NUTRENA MILLS,  
 INC., hereinafter called Mortgagee, the receipt of which is hereby acknowledged, and such future advances that may be made to  
 Mortgagor by Mortgagee, do hereby grant, bargain, sell and transfer unto said Mortgagee, the following described personal  
 property, to-wit:

1. 9 Brook Lane and 48 Mike Brook & Lep Wagon, together  
 with increases thereof, being all the chattels of like kind owned by mortgagor.

2. All poultry feeds, livestock feeds (if any), and grains purchased by Mortgagor out of moneys advanced by Mortgagee which  
 Mortgagor may now have or hereafter acquire.

3. 211

4. All other personal property of like kind with property described in paragraphs numbered 1, 2 and 3 hereafter acquired by  
 Mortgagor until all indebtedness secured by this mortgage is paid.

ALL PROPERTY mortgaged hereunder being located, or to be located, on premises owned or leased by Mortgagor commonly  
 known as the H. S. Wilton farm which premises lies wholly or in part in  
 Section 31, Township 10 S, Range 10 E, County of Shelby, State of Ala.

TO HAVE AND TO HOLD the same unto Mortgagee, its successors and assigns forever. Said Mortgagor covenants to and  
 with the Mortgagee, its successors and assigns, that the Mortgagor is lawfully possessed of the above goods and chattels as its  
 own property; that the same are free from all encumbrances except none  
 and that he (they) will warrant and defend the same to the Mortgagee and its successors and assigns, against all claims and  
 demands of all persons.

PROVIDED, NEVERTHELESS, that if Mortgagor shall pay or cause to be paid to Mortgagee or assigns, according to the  
 terms of a certain promissory note No.       , dated        1962, made by Mortgagor to  
 the order of Mortgagee, any and all other sums now or hereafter owed, together with interest provided, if any, whether evidenced  
 by notes or otherwise, by Mortgagor to Mortgagee and shall fully and punctually perform all covenants contained in notes, if any,  
 evidencing such indebtedness, and in a Nutrena Finance Agreement or Agreements executed by and between Mortgagor and  
 Mortgagee, to be kept and performed by Mortgagor, then these presents shall be void, otherwise they shall remain in full force  
 and effect.

The advances (creating the indebtedness to be secured by this mortgage) shall be completed within two years from the date  
 hereof and such indebtedness, which shall not exceed at any one time \$ 9000,  
 shall mature and shall be payable in full before the expiration of two years from the date hereof.

If default be made in the payment of the principal or interest of any indebtedness secured hereby Mortgagor authorizes  
 Mortgagee to exercise, in addition to the rights granted by law, all or any of the rights granted Mortgagee by Mortgagor in the  
 agreement referred to hereinabove.

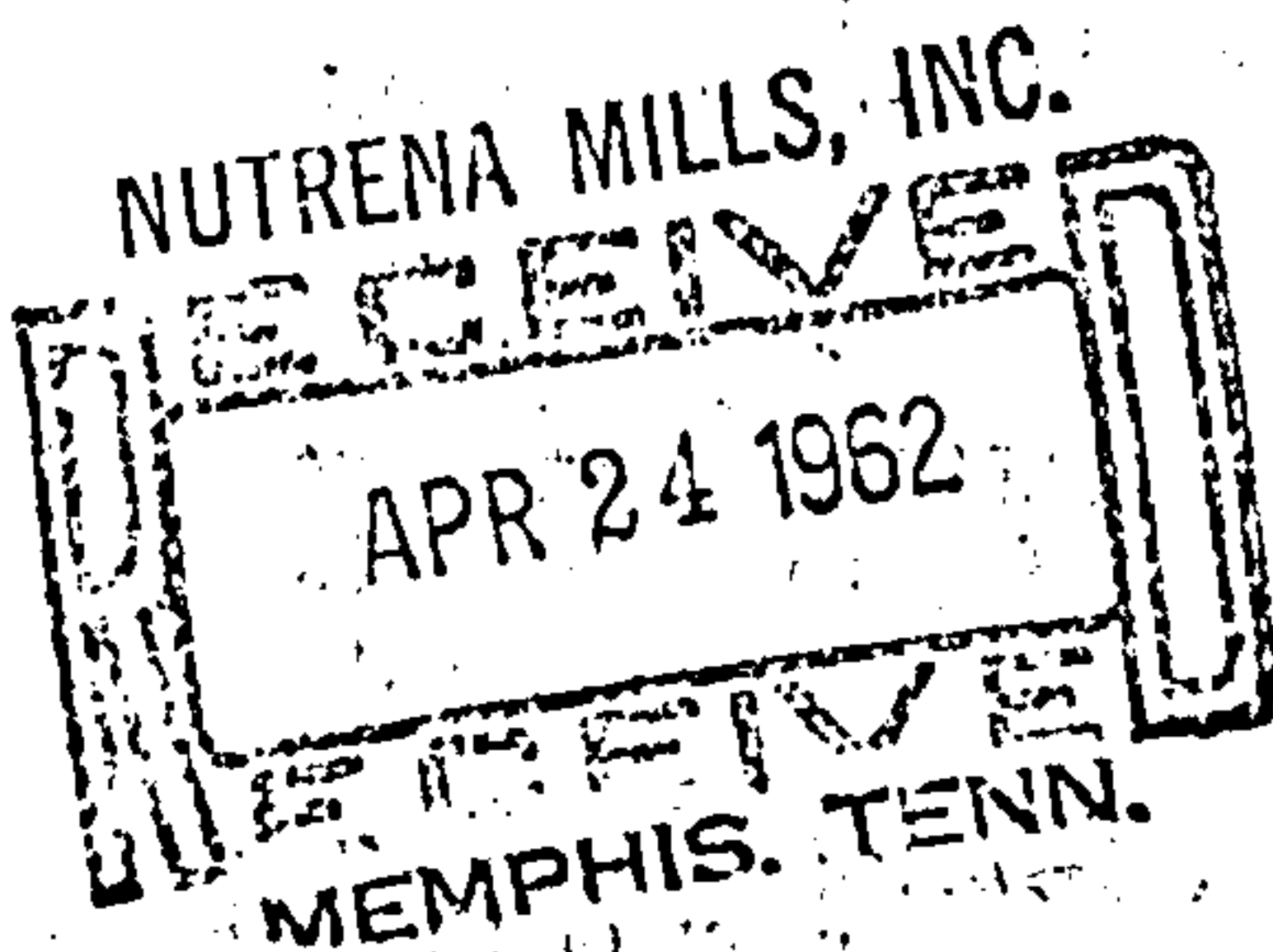
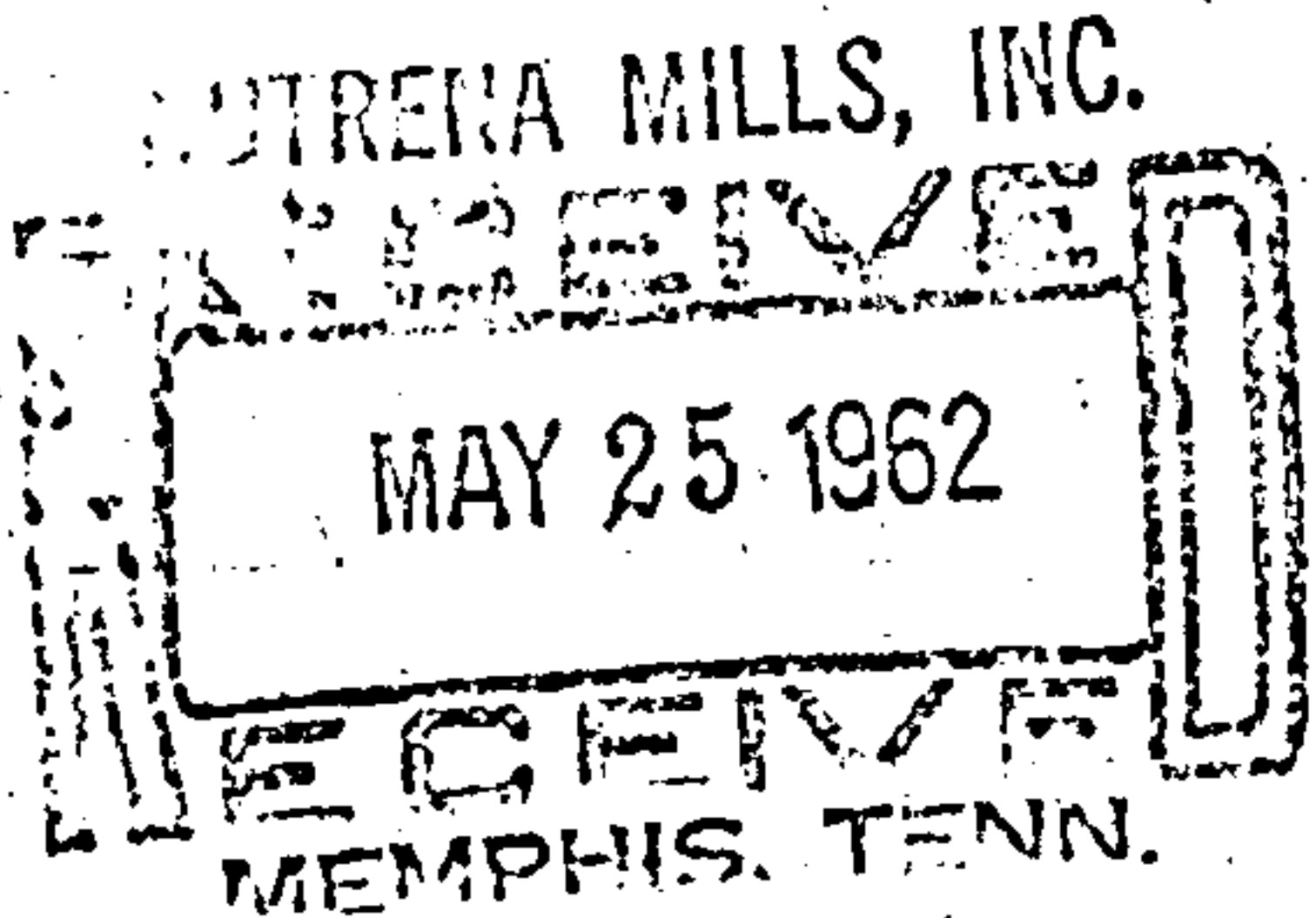
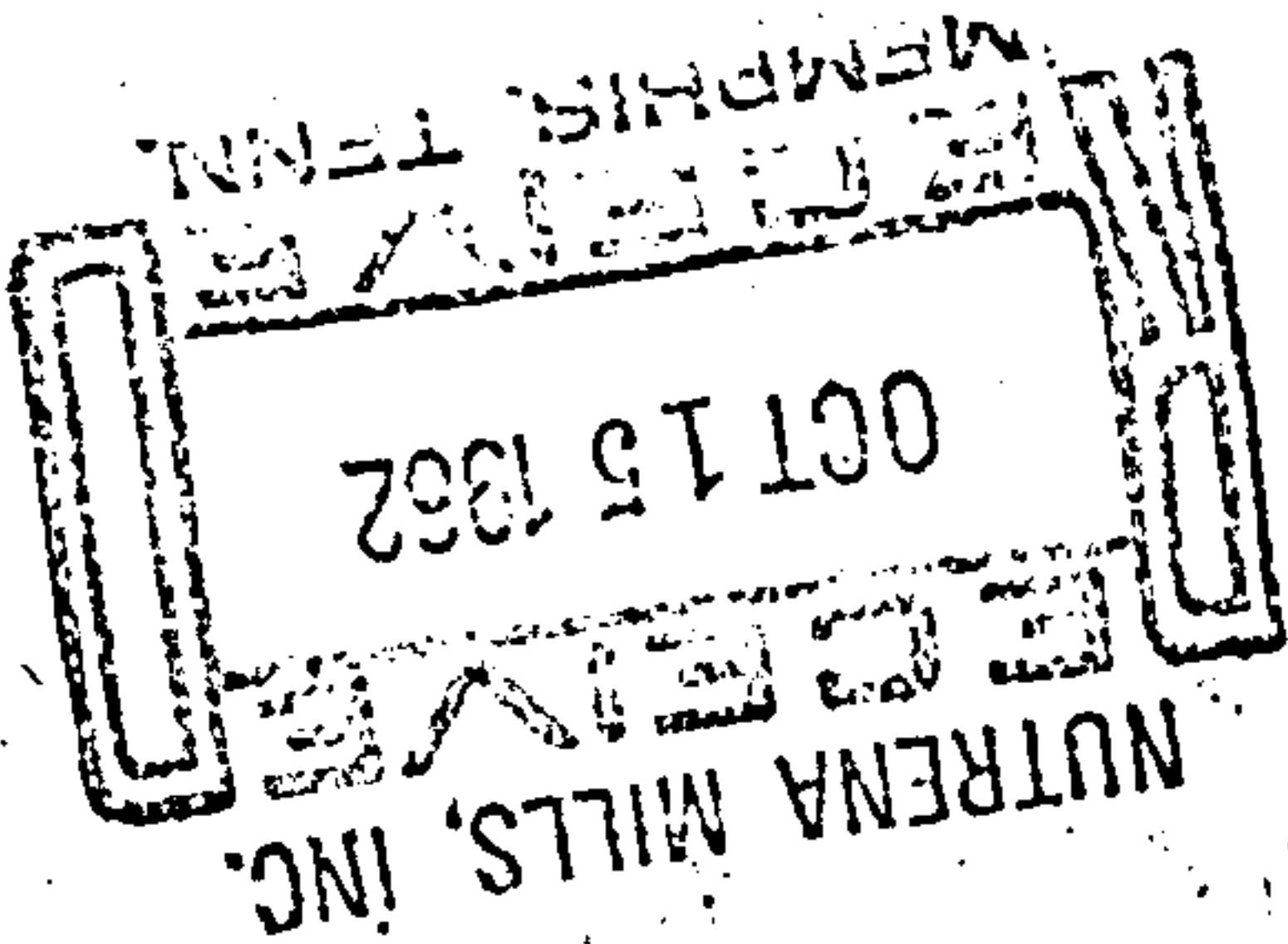
