for and in consideration of the sum of ONE 00/100 Dollars (\$ 1.00), to ME in hand paid by Alabama Power Company, a corporation, the receipt of which is hereby acknowledged, do hereby grant to said Alabama Power Company, its successors and assigns, the right to implant, install and maintain anchor of wood or other material at ONE point on the property hereinafter described, and to construct, extend and maintain guy wires from said anchor to structures now erected or hereafter to be erected on said land. Said anchor and guy wires to be located on and across lands of the undersigned in the County of SHELBY, State of Alabama:

A LOT IN THE TOWN OF CALERA, ALABAMA BEGINNING ON THE EAST RIGHT OF WAY LINE OF U.S. HIGHWAY NO. 31 NEAR THE CENTER OF BLOCK 271, DUNSTON'S MAP OF CALERA, AND RUNNING THENCE SOUTH ALONG THE EAST RIGHT OF WAY LINE OF SAID U.S. HIGHWAY NO. 31 A DISTANCE OF 60 FT; THENCE TURN AN ANGLE OF 90° LEFT AND RUN A DISTANCE OF 150 FT; THENCE TURN AN ANGLE OF 90° LEFT AND RUN A DISTANCE OF 60 FT; THENCE TURN AN ANGLE OF 90° LEFT AND RUN A DISTANCE OF 150 FT. TO POINT OF BEGINNING.
