STATE OF ALABAMA, County of SHELLBY WE, TILLIAMAN DAVIS AND WIFE PHYLLIS DAVIS for and in consideration of the sum of our Dollars (\$ 100 ) to u.5 in hand paid by Alabama Power Company, a corporation, the receipt whereof is acknowledged, do hereby grant to said Alabama Power Company, its successors and assigns, the right to construct, operate and maintain its lines of poles and towers and appliances necessary in connection therewith, as located by the final location survey heretofore made by said Company, for the transmission of electric power with the right to string thereon from time to time electric power and telephone wires and the right to permit other corporations and persons to attach wires to said poles and towers upon, over, under and across the following described lands situated in SHELLBY County, Alabama: A PARCEL OF LAND IN THE SET OF SECTION 16, TOWNSHIP 22 SOUTH, RANGE 3 WEST, MORE PARTICULARLY DESCRIBED AS FOLLOWS; COMMENCE AT THE SW CORNER OF SAID SET AND BUY EAST ALONG THE SOUTH HINE OF SAID SET, A DISTANCE OF SHET; THENCE RUN NORTH PARALLEL WITH WEST HINE OF SAID SELL SHEFT. TO THE MORTH SIDE OF MONTEVALUO - ASHVILLE ROAD THEUSE CONTINUE DORTH ALONG LAST MENTIONED COURSE A DISTANCE OF 1133 FEET THENCE FOU FAST PARALLEL WITH STUTH HIVE OF SAID SELL A DISTANCE OF 636 FEET, THENCE ROW SOUTHEASTERLY AND PERPENDICALLAR TO SAID WINTENALLO MOHILLE ROAD 220 FEET MORE OR DESS TO A POLYT 140 FEET FROM NOISTWEST WINE OF SAID ROAD WHICH IS THE POINT OF REGINNUG; THENCE CONTIDUE ALLONG HAST MENTIONED COURSE 140 FEET TO NORTHWEST HUR OF SAID ROAD; THENCE RON SOUTHWEST ALONG NORTHWEST HIDE OF SAIR ROAD A RISTAUCE OF 300 FEET, THENCE RUN WRITHWESTERLY. VERPEN DYGOLAR TO SAID ROAD A DISTANCE OF 140 FEET, THENCE RUN NORTHEASTERLY PARALLEL WITH SAID ROAD & DISTANCE OF 300 FECTTO POINT OF BEGINNING-In the event it becomes necessary or desirable for Alabama Power Company to move its lines of poles, towers and appliances in connection with the construction or improvement of any public road or highway in proximity to its said power lines, the said Company is hereby granted the right to relocate its said lines of poles, towers, and appliances on lands of grantors hereinabove described, provided, however, the said Company shall relocate its said line of poles or towers at a distance not greater than ten seet outside the boundary of the right of way of any such public road or highway as established or re-established from time to time. Together with all the rights and privileges necessary or convenient for the full enjoyment or use thereof, including the right of ingress and egress to and from said lines; and also the right to cut and keep clear all trees, and to keep clear other obstructions, that may injure or endanger said lines.
