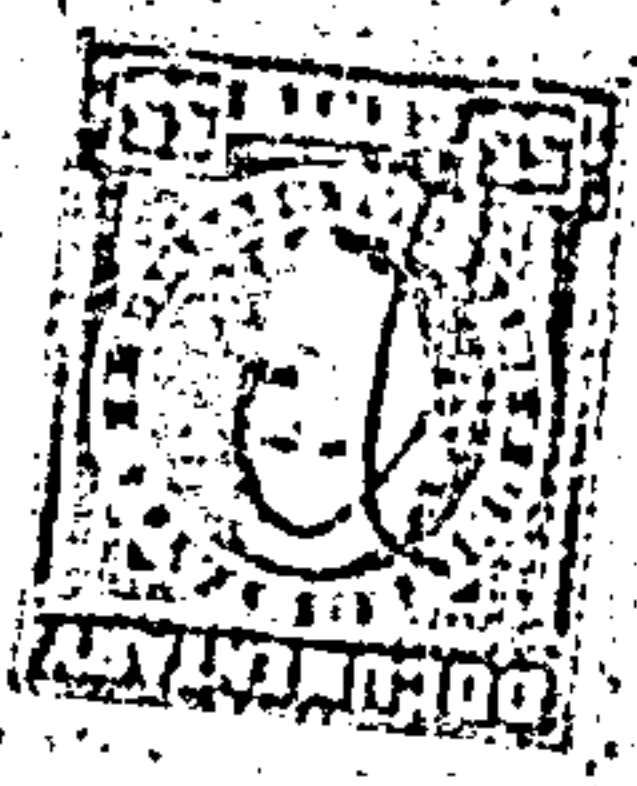


WARRANTY DEED
