Before me, the undersigned Notary Public in and for said County and State, personally appeared Nellie Davidson Mullins, who is known to me, and who, being by me first duly sworn, deposes and says on oath as follows:

My name is Nellie Davidson Mullins. I am 66 years of age and have been a resident of Helena, Shelby County, Alabama, all of my life. My husband was Luther C. Mullins, who died in 1953.

C. T. Davidson was my father; he died intestate more than 15 years ago while a resident of Shelby County, Alabama. My mother, Laura Bell Davidson, died a short time after my said father's death.

Other than me, said C. T. Davidson had seven other children. Two of these, Morris Davidson and Louie Davidson, both boys, died in infancy, and another, Margaret Davidson, a girl, died without ever having children or without ever being married.

Another daughter of said C. T. Davidson is Ada Davidson Lowery, who is a widow.

Another son of C. T. Davidson is J. W. Davidson, who is unmarried.

The two remaining sons of C. T. Davidson are both deceased, namely, J. S. Davidson and R. B. Davidson.

The widow of said J. S. Davidson is Emmie Davidson; said J. S. Davidson died intestate while a resident of Shelby County, Alabama, about 20 years ago. Said J. S. Davidson had only two children, both of whom are living and over 21 years of age, namely, Marion Davidson Sides, who is married to James Sides, and Joseph R. Davidson, who is married to Carolyn Davidson.

The widow of said R. B. Davidson is Ruth Davidson; said R. B. Davidson died intestate while a resident of Shelby County, Alabama, about 3 years ago. Said R. B. Davidson had only six children, all of whom are living and over 21 years of age, namely, R. B. Davidson, Jr., whose wife is Nobie Davidson; Evans Davidson, whose wife is Syble Davidson; Elizabeth Davidson Baker, who is a widow; Gerald Davidson, who is an unmarried man; Virginia Davidson Wade, who is married to Harry Wade; and Charles Davidson, who is an unmarried man.

It has been pointed out to me that said C. T. Davidson at one time owned Lot 10, Block 4, as per Joseph Squire's Survey of Helena, Alabama, as shown at page 121 of Map Book 3, Office of Judge of Probate, Shelby County, Alabama. I was not aware until recently that my said father had ever owned this property; I never heard him make any claim to it during his life-time, and I have never

heard any of the children or heirs of said C. T. Davidson, as mentioned herein, making any claim whatsoever in said property. Said property is in an undeveloped and uninhabited part of Helena, there being no houses or fences or structures of any nature on said property until recently when James H. Bunch began constructing a house thereon. I know of my own personal knowledge, having been a resident of Helena, Alabama, all of my life, that said property was not in the possession of anyone for at least a 20 year period prior to the time when said James H. Bunch took said property into his possession two years ago.
