Alabama and State of Florida, more particularly described as follows: Begin where the East Sec.  
line intersects the T.C.I. RR. Right of way marked by an  
iron stake, Thence West 210 Ft. thence south 105 Ft. the  
point of beginning thence continue South 105 Ft., thence East  
210 Ft., thence North 105 Ft., thence West 210 Ft. to the  
point of beginning lying and being in the NE 1/4 of NW 1/4  
of Sec. 33 Tp. 18 Range 2 East, Shelby County, Alabama.

TOGETHER with all the tenements, hereditaments and appurtenances, with every privilege, right, title, interest and estate, dower and right of dower, reversion, remainder and easement thereto belonging or in anywise appertaining: TO HAVE AND TO HOLD  
the same in fee simple forever.

are lawfully seized of the said premises, that they are free from all encumbrances
