Before me, a Notary Public in and for said County and State, personally appeared Rosie Williams, who is known to me, and who, being by me first sworn, deposes and says on oath, as follows:

My name is Rosie Williams. I am 60 years old and have lived in the close vicinity of the following described property all of my life:

Commence at the southwest corner of the SW $\frac{1}{4}$ of SE $\frac{1}{4}$ of Section 4, Township 22 South, Range 2 West, and in a northerly direction along the west line of said quarter-quarter, run a distance of 141.41 feet; thence turn an angle of 93 deg. 14 min. to the right for a distance of 352.4 feet; thence turn an angle of 92 deg. 25 min. to the right for a distance of 126.6 feet to a point on the south line of said quarter-quarter section; thence turn an angle of 85 deg. 06 min. to the right and run west along the south line of said quarter-quarter section a distance of 339.41 feet to the point of beginning.

The above described property lies about 125 feet west of Highway 31, and is bounded on the north and east by property of John Herndon and on the south by a dirt road leading in a westerly direction from Highway 31. The New Mount Moriah Baptist Church fronts on Highway 31 just south of said dirt road running by the southern boundary of said property.

I have been familiar with the ownership and possession of said property since before 1911: I remember when Moriah Trenholm, owned said property and when she conveyed it to her daughter, Hannah Oden. I remember when said Hannah Oden and her husband, Kersey Oden, conveyed said property to Mose Cook, about 1923.

I have been a neighbor of said Mose Cook since he bought said property and during the time he and his wife, Lucy Cook, lived on said property. Mose and Lucy Cook lived on said property as their homestead, occupying the house which is still standing on said property, since about 1923 until said Lucy Cook died, about 1950. They raised a family in said house.

I have never heard of Anderson Brown, or any of his heirs or children, or Susan Hart, or John Johnston, or any other person owning, possessing, or claiming said property, or any part thereof, or any interest therein, other than said Mose Cook and his predecessors in title, as stated above. I know of my own personal knowledge that said Mose Cook and his predecessors in title as named above have been in the continuous, actual, peaceable, exclusive, notorious, hostile, open, adverse possession of all of said property since prior to 1910 and until the present date. I have never heard anyone question the title of said Mose Cook and his predecessors in title.
