EXTENSION OF TRUST FOR ANNE BELCHER  
HAYDOCK, NEE KATHERINE ANNE BELCHER

THIS AGREEMENT made and entered into by and between Anne Belcher Haydock, nee Katherine Anne Belcher (hereinafter sometimes referred to as "Anne Belcher Haydock"), and Nell Vandergrift Belcher, as Trustee (hereinafter sometimes referred to as "Trustee");

W I T N E S S E T H:

THAT WHEREAS, heretofore on, to-wit, the 23rd day of December, 1940, William Albert Belcher, Sr. and the aforesaid Nell Vandergrift Belcher, as Trustee for Katherine Anne Belcher, entered into that certain Indenture and Deed of Trust that was later recorded in the Office of the Judge of Probate of Jefferson County, Alabama, on the 27th day of December, 1940, in Volume 3150 Record of Deeds, at page 141; and,

WHEREAS, under said Indenture and Deed of Trust said Trust would terminate on, to-wit, December 13, 1961, but Anne Belcher Haydock elected to continue and extend same for an additional term of ten (10) years, to and including December 13, 1971, and she is desirous of evidencing her said election to continue and extend the term of said Trust by this written instrument duly recorded in the Office of the Judge of Probate of Jefferson County, Alabama.

NOW, THEREFORE, PREMISES CONSIDERED, I, the said Anne Belcher Haydock, nee Katherine Anne Belcher, do hereby make known to all whom this may concern, that I have hereto elected and do hereby elect to continue in full force and effect under the same terms and conditions and to extend for a term of ten (10) years from the 13th day of December, 1961, and from time to time thereafter as I may elect by written instrument duly recorded in the

Office of the Judge of Probate of Jefferson County, Alabama, that certain Trust that was created for my benefit on the 23rd day of December, 1940, as aforesaid, by Indenture and Deed of Trust recorded in the Office of the Judge of Probate of Jefferson County, Alabama, on the 27th day of December, 1940, in Volume 3150 Record of Deeds, at page 141, and I, the said Anne Belcher Haydock, do hereby ratify and confirm all actions and deeds of the said Nell Vandergrift Belcher, as Trustee under said Indenture and Deed of Trust since her acceptance of said Trusteeship on the 23rd day of December, 1940, and I do hereby further confirm and make known the fact that the Trustee under said Indenture and Deed of Trust, during the period of ten (10) years from and after the 13th day of December, 1961, has had, shall have and is hereby given all of the rights, powers and duties in the administration of the Trust Estate covered by said Indenture and Deed of Trust, as she had during the period from the 23rd day of December, 1940, to and including 13th day of December, 1961.

IN WITNESS WHEREOF, the undersigned, Anne Belcher Haydock, has hereunto affixed her signature and seal and Nell Vandergrift Belcher has executed this agreement as Trustee, as further evidence of her acceptance of said Trusteeship, under date of the 10th day of March, 1961.




