Before me, a Notary Public in and for said County and State, personally appeared Mildred Boothe, who is known to me, and who being by me first duly sworn, deposes and says as follows:

My name is Mildred Boothe. I am thirty-six (36) years of age, and my husband is Robert G. Boothe. I have lived in the community known as Dogwood, Shelby County, Alabama, all of my life.

I have been familiar with the ownership and possession of the following described property, now owned by P. C. Belcher, Jr., and Mavis Belcher, since the time said property was owned by Little Gem Coal Company and for more than twenty (20) years, said property being described as follows:

For the Point of Beginning, begin at a Point 153.7 feet North and 526.2 feet West of the Center Stake of Section 5, Township 22 South, Range 3 West; thence run North 57 deg. 50 min. West for a distance of 130.0 feet; thence run North 32 deg. 10 min. East for a distance of 115.0 feet; thence run South 57 deg. 50 min. East for a distance of 130.0 feet; thence run South 32 deg. 10 min. West for a distance of 115.0 feet, to the Point of Beginning, also, the following described property - Commence, at the above said Point of Beginning and run North 32 deg. 10 min. East for a distance of 100.0 feet; thence run South 57 deg. 50 min. East for a distance of 50.5 feet; thence run South 32 deg. 10 min. West for a distance of 100.0 feet; thence run North 57 deg. 50 min. West for a distance of 50.5 feet, to the Point of Beginning.

I have also been familiar for many years with the property owned by Frank Fortenberry and upon which said Frank Fortenberry and his wife reside as their homestead. Said Frank Fortenberry bought said property from my sister, Mrs. R. F. Price, and her husband, about three (3) years ago. Said Mr. and Mrs. Price bought said property a few years before that from Barney Moon and wife, Audrey Moon.

The above described property owned by said P. C. Belcher, Jr., and wife, Mavis Belcher, is situated some seven or eight hundred feet from said property now owned by Frank Fortenberry. Said Frank Fortenberry and wife have never possessed or claimed any part of said above described property owned by R. C. Belcher, Jr., and wife, Mavis Belcher.

I know Mr. Henry Brantley, who owned the above described property prior to R. C. Belcher, Jr., and wife, Mavis Belcher, and I know that he is also known as "H. T. Brantley", and he is also known as "T. H. Brantley", and he is one and the same person as "H. T. Brantley".
