TO THE HONORABLE J. PAUL MEEKS, PROBATE JUDGE
OF JEFFERSON COUNTY, ALABAMA:

Now comes your petitioner, June Fore Shaw, and respectfully
states, avers and shows unto the Court as follows:

1. That she is over the age of twenty-one (21) years, under
no legal disability, and a bona fide resident of Jefferson County,
Alabama.

2. That she is the mother of Trinket Fore Shaw, a minor
under the age of fourteen years. Petitioner avers that, pursuant to
a Final Decree of Divorce entered in the Circuit Court of Tuscaloosa
County, Alabama, in February, 1954, the bonds of matrimony have been
dissolved between petitioner and the father of said minor, Pharis B.
Shaw, and that said decree of divorce provides that petitioner shall
have the exclusive care, custody and control of said minor child.

3. Petitioner avers that the name given to her minor child
at birth was Trinket Fore Shaw and that petitioner and said minor
child now desire to have her name changed from Trinket Fore Shaw to
Tracy Fore Shaw and to be known henceforth by Tracy Fore Shaw alone.

WHEREFORE, premises considered, petitioner respectfully prays
that the Court will enter an order which will duly and legally effect
the change of name so that hereafter the name of said minor child
will legally be Tracy Fore Shaw, and petitioner prays for such other,
further or different relief to which she may be entitled in the
premises.
