Walker, the receipt whereof is hereby acknowledged, we the said R. F. Cox, Jr. and wife, Jewel Cox; Olive N. Holman, a widow; Lena Cox; Corella Farley Green and husband, W. O. together with full and free right of ingress and egress to and from said land at any and all times until the expiration of one year from the execution of this instrument for the purpose of cutting and removing said timber, but after said time, grantee shall have no further rights or interest in said land or timber and at the expiration of said time, said land and all uncut timber shall revert to the grantors herein.

All being situated in Shelby County, Alabama,

The grantees shall use all reasonable care to prevent any part of said land from being burned over, and shall do no unnecessary damage to timber not herein conveyed.

And we do and for our heirs, executors and administrators covenants with the said Lewis B. Walker, his heirs and assigns, that we are lawfully seized of said premises; that it is free from all encumbrances and we have a good right to sell and convey mid timber as aforesaid; that we will and our heirs, executors and administrators shall warrant and defend the same to the said Lewis B. Walker, his heirs and assigns against the lawful chaims of all persons.


