




EASEMENT

KNOW ALL MEN BY THESE PRESENTS. That for and in consideration of Sixteen Thousand, Eight Hundred to Kimberly-Clark Corporation Eighty-Five and 60/100 (\$16,885.80) (hereinafter sometimes referred to as Grantor), in hand paid by Colonial Pipeline Company, a Delaware corporation (hereinafter sometimes referred to as Grantee), Grantor hereby grants to Grantee, its successors and assigns, a right of way and easement of fifty (50) feet in width, for the purpose of constructing, maintaining, inspecting, operating, protecting, repairing, replacing, or removing a pipeline or pipelines, for the transportation of oil, gas and the products or derivatives thereof, upon and along a route over, across, through and under the following described lands situated in BIBB, SHELBY, TALLADEGA AND CLEBURNE COUNTIES, ALABAMA, and all as more particularly shown by alignment sheets, numbers 61, 62, 66, 67, 72a, 72b, 73, 74, 75a, 75b, 75c, 80, 81a, 81b, 82 attached hereto and made apart hereof, which correctly show the location of the proposed pipe line, to wit:


Commencing at the Northwest corner of the Northeast Quarter of the Southwest Quarter (NE+ of SW+) of Section 36. Township 21 South, Range 6 West, thence run South 90 feet to the point of beginning, thence run North 70 degrees 00 minutes East 245 feet to a point 225 feet East of the Northwest corner of the Northeast Quarter of the Southwest Quarter (NE+ of SW+) of Section 36. Township 21 South, Range 6 West.





Commencing at the Northwest corner of the Southwest Quarter of the Northwest Quarter (SW; of NW;) of Section 31. Township 21 South, Range 5 West, thence run North 64 feet to the point of beginning, thence run North 71 degrees 45 minutes East 864 feet to a point, thence run North 77 degrees 45 minutes East 514 feet to a point 864 feet South of the Northwest corner of the Northwest Quarter of the Northwest Quarter (NW; of NW;) of Section 31. Township 21 South, Range 5 West.

Commencing at the Northwest corner of the Northwest Quarter of the Northeast Quarter (NWC of NEC) of Section 31. Township 21 South, Range 5 West, thence run South 516 feet to the point of beginning, thence run North 77 degrees 45 minutes East 293 feet, thence run North 77 degrees 08 minutes East 1049 feet to a point 207 feet South of the Northeast corner of the Northwest Quarter of the Northwest Quarter of the Northwest Quarter (NWC of NEC) of Section 31. Commencing at the Southwest corner of the Northwest Quarter of the Northwest Quarter (NW; of NW;) of Section 10, Township 20 South, Range 1 West, thence run North 350 feat to the point of beginning, thence run North 68 degrees 00 minutes East 2554 feet to a point 333 feet West of the Northeast corner of the Northeast Quarter of the Northwest Quarter (NE; of NW;) of Section 10, Township 20 South, Range 1 West.

Commencing at the Northwest corner of the Southwest Quarter of the Northeast Quarter (SW; of NE;) of Section 32. Township 19 South, Range 1 East, thence run South 293 feet to the point of beginning, thence run North 71 degrees 30 minutes East across Section 32 and into Section 33, 4298 feet to a point 103 feet South of the Northwest corner of the Northwest Quarter of the Northwest Quarter (NW; of NW;) of Section 33, Township 19 South, Range 1 East.

Commencing at the Northwest corner of the Southwest Quarter of the Southeast Quarter (SW of SE of SE of Section 35, Township 17 South, Range 5 East, thence run South 31 feet to the point of beginning, thence North 63 degrees 30 minutes East 3098 feet to a point 100 feet West of the Northeast corner of the Northeast Quarter (NE of SE of SE of Section 35, Township 17 South, Range 5 East.

Township 16 South, Rango 10 East.

Commencing at the Northwest corner of the Southwest Quarter of the Northeast Quarter (3% of NEt) of Section 14, Township 16 South, Range 10 East, thence run South 500 foot to the point of beginning, thence run North 72 dograes 00 minutes East 1570 feet to a point 246 foot East of the Northwest corner of the Southeast Quarter of the Northeast Quarter (SEt of NEt) of Saction 14. Township 16 South, Range 10 East.

Commoncing at the Northwest corner of the Northeast Quarter of the Northwest Quarter (NE's of NW's) of Section 9. Township 16 South, Range 11 East, thence run South 763 feet to the point of beginning, thence run North 74 degrees 07 minutes East 2934 feet to a point 73 foot East of the Northwest corner of the Northnast Quarter of the Northeast Quarter (NE's of NET) of Soction ?. Township 16 South. Rango 11 East.

Commoncing at the Northwest corner of the Southwest Quarter of the Southeast Quarter (5% of SE2) of Section 3, Township 16 South, Range 11 East, thence run South 197 foot to the point of beginning, thence run North 76 degroes 00 minutes East 776 feet to a point 1902 foot Wost of the Southeast corner of the Northeast Quarter of the Southeast Quarter (NEt of SEA) of Section 3. Township-16 South, Range 11 East.

Commencing at the Southwest corner of the Northeast Quarter of the Southeast Quarter (NE 4 of SE 4) of Section 3. Township 16 South, Range 11 East, thence run North 150 feet to the point of beginning, thence run North 76 degrees 00 minutes East 232 feet to a point, thence run North 75 degrees 00 minutes East across Section 3 and into Section 2, 2165 feet to a point, thence run North 74 degrees 00 minutes East 358 feet to a point 441 feet South of the Northeast corner of the Northwest Quarter of the Southwest Quarter (NW of SW of Section 2, Township 16 South, Range 11 East.

Commencing at the Northwest corner of the Southeast Quarter of the Southwest Quarter (SE; of SW;) of Section 26, Township 15 South, Range 12 East, thence run South 428 feet to the point of beginning, thence run North 67 degrees 30 minutes East 1131 feet to a point 305 feet West of the Northeast corner of the Southeast Quarter of the Southwest Quarter (SE; of SW;) of Section 26, Township 15 South, Range 12 East.

And for the same consideration, Grantor further grants to Grantee the right to cut and remove during construction of said pipeline all timber located on the land of Grantor not more than twenty-five (25) feet in a northwesterly direction nor more than fifty (50) feet in a southeasterly direction from the centerline of said pipeline. After construction has been completed and the temporary working strips abandoned, Grantee shall thereafter have the right to cut such timber located on land of Grantor as may endanger the safety of or interfere with the proper operation and maintenance of said pipeline but shall pay Grantor for the reasonable timber market value of any trees cut which are more than fifteen (15) feet from and on the northwesterly side of the centerline of said pipeline or more than thirty-five (35) feet from and on the southeasterly side of said centerline, such area being the fifty (50) feet wide permanent right of way easement herein granted.

Should more than one pipeline be laid under this grant, or should the length of the pipeline be increased in any manner at any time, an additional consideration, calculated on the basis of One Dollar (\$1.00) per lineal rod, shall be paid to Grantor. It is agreed that all of said pipelines shall be located within the above described right of way.

Grantor shall have the right to use and enjoy the above described premised, except as to the rights granted herein, and Grantor agrees not to build, create or construct, nor permit to be built, created or constructed (except through exercise of the power of eminent domain or

condomnation or for other reasons beyond its control) any obstruction, building, lake, engineering works, or other structure over said pipeline or pipelines. Grantee hereby agrees to pay any damages which may arise to growing crops, timber, fences or building of said Granter from the exercise of the rights herein granted. Said damages, if not mutually agreed upon, are to be ascertained and determined by three disinterested persons, one thereof to be appointed by Granter, one by Grantee and the third by the two so appointed, and the written award of such three persons shall be final and conclusive.

Grantoe hereby agrees to indemnify and hold harmless the Grantor for any liability that it might incur as a result of Grantee's use of said right of way.

Any pipelines constructed by said Grantee across lands under cultivation shall, at the time of construction thereof, be buried to such depth as will not interfere with such cultivation.

The rights herein granted may be assigned in whole or in part.




