Know All Men By These Presents.

That in consideration of One Thousand and No/100 (\$1,000.00) - - - - - DOLLARS and assumption of mortgage hereinafter referred to,

to the undersigned grantors Walter S. Naish and Evelyn L. Naish

in hand paid by Charlie Lewis Garner and Sarah H. Garner

the receipt whereof is acknowledged we the said Walter S. Naish and wife, Evelyn L. Naish,

do grant, bargain, sell and convey unto the said Charlie Lewis Garner and Sarah H. Garner,

as joint tenants, with right of survivorship, the following described real estate, situated in

Shelby County, Alabama, to-wit:

Start at the Southwest corner of NW $\frac{1}{4}$ of NW $\frac{1}{4}$ of Section 13, Township 20 South, Range 4 West, thence run East along the South line of said NW $\frac{1}{4}$ of NW $\frac{1}{4}$ a distance of 170 feet for the point of beginning, thence turn an angle of 98° 03' to the left and run Northwesterly a distance of 327.8 feet, thence turn an angle of 53° 22' to the right and run Northeasterly a distance of 39.7 feet, thence turn an angle of 56° 26' to the right and run Southeasterly a distance of 58 feet, thence turn an angle of 66° 27' to the right and run Southeasterly a distance of 344.9 feet, thence turn an angle of 101° 48' to the right and run West a distance of 110.9 feet to the point of beginning.

This property is subject to mortgage to Guaranty Savings & Loan Association of record in Volume 192 of Mortgages at page 422, in the Office of the Judge of Probate of Shelby County, Alabama. The grantees herein, as a part of the consideration for this conveyance, assume said mortgage and assume and agree to pay the indebtedness thereby secured on the terms and in the manner therein specified.

TO HAVE AND TO HOLD Unto the said Charlie Lewis Garner and Sarah H. Garner

as joint tenants, with right of survivorship, their heirs and assigns forever; it being the intention of the parties to this conveyance, that (unless the joint tenancy hereby created is severed or terminated during the joint lives of the grantees herein), in the event one grantee herein survives the other, the entire interest in fee simple shall pass to the surviving grantee, and if one grantee does not survive the other, then the heirs and assigns of the grantees herein shall take as tenants in common.

And we do, for ourselves and for our heirs, executors and administrators, covenant with the said grantees, their heirs and assigns, that we are lawfully seized in fee simple of said premises; that they are free from all encumbrances; except mortgage hereinabove referred to and current year's taxes which grantees also assume and agree to pay,

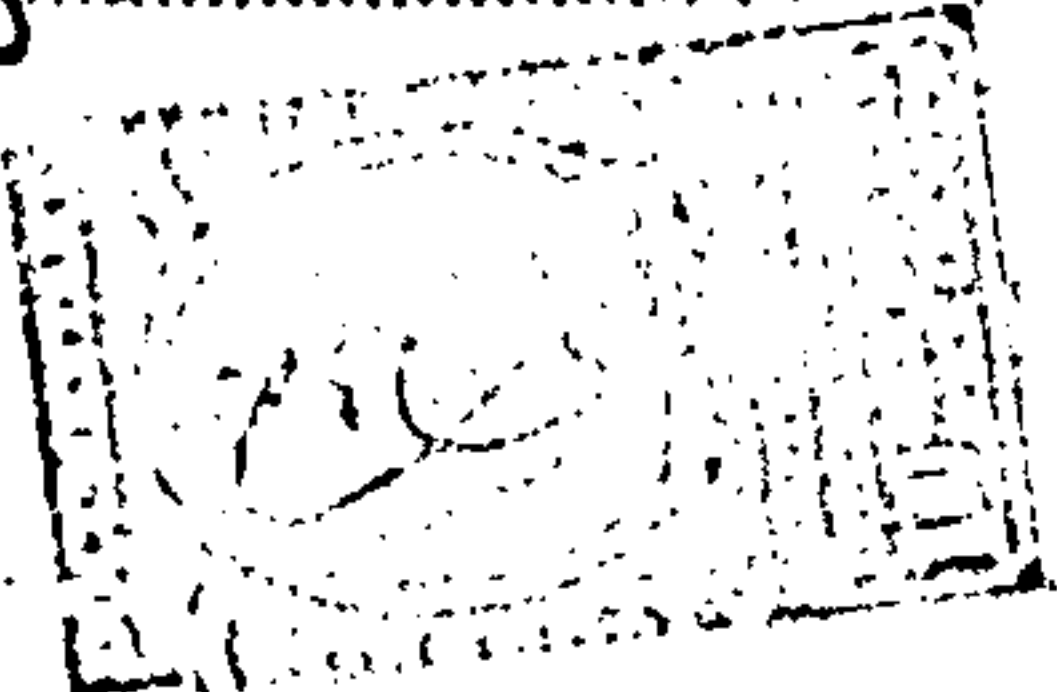
