Thence continue Northerly along the East boundry line of said SE 1/4 of SE 1/4 for 166.28 feet; thence turn an angle of 89°51'23" to the left and run Westerly 600 feet; thence turn an angle of 90°08'37" to the left and run Southerly 130 feet, more or less to a point on the North R.O.W. of said County Road; thence run Easterly along the North R.O.W. line of said County Road for 600 feet, more or less, to the point of beginning.
