RELEASE OF MORTGAGE

KNOW ALL MEN BY THESE PRESENTS: That

WHEREAS, the undersigned Ruth Williams holds a mortgage on the undivided interest of Sam J. Street in and to the property hereinafter described and other property by virtue of a mortgage recorded in Volume 275 page 594 in the office of the Judge of Probate of Shelby County, Alabama, and

WHEREAS, the undersigned Ruth Williams has agreed to release the property hereinafter described from the aforesaid mortgage;

NOW, THEREFORE, in consideration of \$1.00 and other considerations to the undersigned Ruth Williams, in hand paid by Sam J. Street the receipt whereof is hereby acknowledged, the said Ruth Williams does hereby release the property hereinafter described from the effects and lien of the aforesaid mortgage recorded in Volume 275 page 594 in said Probate Office, and does by these presents remise, release, quitclaim and convey unto the said Sam J. Street, all right, title and interest in and to the following described property situated in Shelby County, Alabama, to-wit:

Plot 1 according to survey made of Lee Street Estate by Alton Young in March 1963, as shown by map recorded in Map Book 4 page 83 in the Probate Office of Shelby County, Alabama, which said Plot 1 is more particularly described as follows: From the southeast corner of Section 15, Township 19, South, Range 2 West run westerly along the south boundary line of the said Section 15 for 943.09 feet to a point in the center of a County Road; thence turn an angle of 78 deg. 32 min. to the right and run northwesterly along the center of said road for 33.28 feet to the point of beginning of the land herein described; thence turn an angle of 75 deg. 11 min. 20 sec. to the left and run northwesterly for 707.04 feet; thence turn an angle of 74 deg. 52 min. 10 sec. to the right and run northwesterly for 265.69 feet; thence turn an angle of 101 deg. 52 min. 10 sec. to the right and run easterly for 681.14 feet, more or less, to a point in the center of said County Road; thence turn an angle of 73 deg. 03 min. to the right and run southeasterly along the center of said County Road for 200.0 feet; thence turn an angle of 05 deg. 24 min. to the right and continue southeasterly along the center of said road for 110.0 feet, more or less to the point of beginning. Also from the southeast corner of Section 15, Township 19 South, Range 2 West run northerly along the east boundary line of the said Section 15 for 793.95 feet; thence turn an angle of 89 deg. 51 min. 23 sec. to the left and run westerly 600 feet to the point of beginning of the land herein described; thence continue westerly along the last said course for 420 feet; thence turn an angle of 90 deg. 08 min. 37 sec. to the left and run southerly 102.0 feet, more or less, to a point on the north right of way line of a New County Road; thence run southeasterly along the north right of way line of said road for 420 feet; thence run northerly parallel to the east boundary line of said Section 15 for 130.0 feet, more or less, to the point of beginning; being a part of the SE $\frac{1}{4}$ of SE $\frac{1}{4}$ of Section 15, Township 19 South, Range 2 West, and being 1.128 acres, more or less.

TO HAVE AND TO HOLD said described property unto the said Sam J. Street, his heirs and assigns forever.

Except as to the property hereinabove described, the said mortgage shall remain in full force and effect.


