Reason Samuel Woolley who is known as Reese Woolley first wife died and he was recently divorced from his second wife. Lizzie Woolley married M. W. Lawley and she is now dead <sup>was</sup> and survived by a husband M. W. Lawley and two children Christine Bales and M. W. Lawley, II. Her son Ralph Lawley was killed in the service during World War II but had never married and had no children. John Woolley died leaving a widow named Verta Woolley and two daughters Mary Lynn Combs and Betty John Brady. Willie Woolley died leaving surviving her a husband whose name was Harvey A. Edge and no children. Mary Ida Woolley and Edward Lee Woolley have never been married.

I know of my own personal knowledge that Robert E. Woolley and since his
