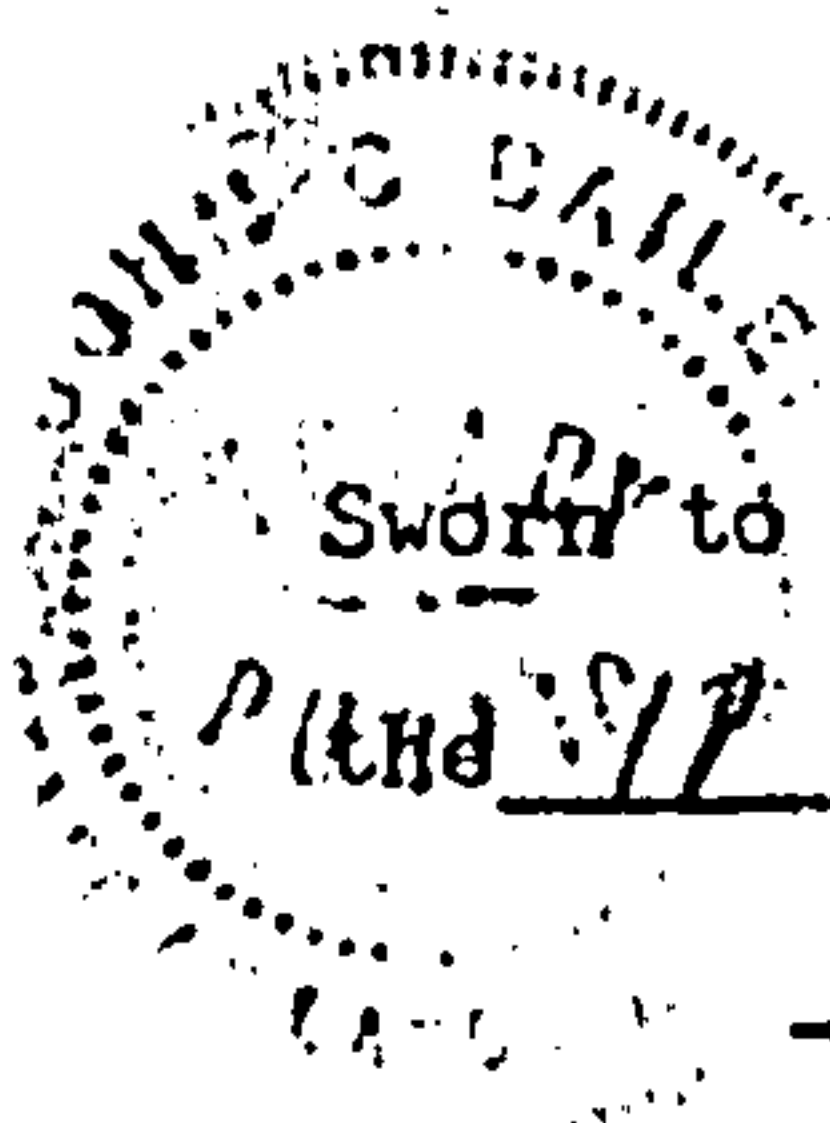

My name is Maurice Hammond. I am 67 years of age. I was formerly one of the owners of and was employed at Keystone Lime Company and was familiar with the J. Ross Hannahan land. I am also familiar with the land owned by Hassie Curry near Keystone, Alabama. Said land owned by Hassie V. Curry being described as follows:

A part of the $N\frac{1}{2}$ of $SW\frac{1}{4}$ of Section 25, Township 20 South, Range 3 West more particularly described as follows: Beginning at the point of intersection of the east right of way line of the Birmingham-Montgomery Highway with the south line of the $NW\frac{1}{4}$ of $SW\frac{1}{4}$ of said Section 25 and run thence north 88 deg. 45 min. East a distance of 975.5 feet to Wilson Road; thence along Wilson road north 8 deg. 15 min. West 279 feet; thence north 38 deg. 15 min. west 110.9 feet; thence north 76 deg. 15 min. west 57.1 feet; thence south 63 deg. 45 min. West 125 feet; thence north 79 deg. 15 min. West 123.2 feet; thence north 66 deg. 07 min. West a distance of 484 feet to the intersection of said road with the east right of way line of said Birmingham-Montgomery Highway; thence run south 13 deg. 23 min. west along said Highway a distance of 587.4 feet to the point of beginning; being situated in Shelby County, Alabama.

I have never heard of Tom Jacks owning or claiming to own any portion of the above described land.
