From the Northeast corner of the NW $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Section 28, T θ . 20 S., Range 3W, run Southerly along the East boundary line of the said NW $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Sec. 28, T θ 20S θ Range 3W, for 383.38 feet to the point of beginning of the land herein described; thence turn an angle of 90 deg. 48 min 15 sec. to the right and run Westerly 266.91 feet: thence turn an angle of 84 deg. 52 min. to the left and run Southwesterly 263.36 feet: thence turn an angle of 95 deg. 07 min. 20 sec. to the left and run Easterly 210.0 feet: thence turn an angle of 84 deg. 14 min 20 sec. to the left and run Northeasterly 158.17 ft.: thence turn an angle of 84 deg. 14 min 20 sec. to the right and run Easterly 210.0 ft.: thence turn an angle of 85 deg 49 min 20 sec. to the left and run Northeasterly 105.4 ft: thence turn an angle of 94 deg. 11 min 20 sec. to the left and run Westerly 153.19 ft. more or less to the point of beginning.
